18	Estimates for Fiscal Year 2013 was formulated.	
19	On February 27, 2013, the Board of Estimates recommended this appropriation to the City

21	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That	
22	\$938,773 shall be made available to the Mayor's Office of Criminal Justice – Service 758	
23	(Coordination of Public Safety Strategy) as a Supplementary Federal Fund Operating	
24	Appropriation for Fiscal Year 2013, to provide funding for community safety initiatives and
