I am herein providing an updated report on City Council Bill 12-0028 introduced by Council Members Kraft, Henry, Cole, Middleton, Stokes, Holton, Branch, Clarke, Spector, Welch, President Young, Council Members Scott, and Curran.

The purpose of the Bill is to modify the authorized methods for complying with automatic-lighting-shutoff requirements; require the use of a room key to activate lighting in sleeping units of hotels, motels, boarding houses, and similar buildings; correct, clarify, and conform related provisions; and provide for the application of this Ordinance to all new construction or substantial improvements for which a permit application is filed on or after January 1, 2013.

Periodically, the City reviews its building, property maintenance, mechanical, plumbing, and related codes and adopts revisions through an ordinance process. Revisions are necessary to keep these codes current and viable, by incorporating new standards, new materials, or new methods for compliance for the health and safety of our citizens. When responding to this legislation in the Department's report dated April 3, 2012, the last major revisions to Baltimore's codes were adopted through Ordinance 11-419. Included in these revisions was the adoption of the International Energy Conservation Code. Since April of 2012 and the preparation of this updated response, the City adopted major revisions to these codes again under Ordinance 13-93 which also included adoption of the International Energy Conservation Code.

As a result of these most recent revisions, the code references in City Council Bill 12-0028 need to be amended, and the Department's previously recommended amendment now affects a different section of the code. The proposed new Department amendment language is provided in Attachment A of this report. The Department is also recommending a series of technical amendments to update the legislation which appear in Attachment B of this report. Due to some significant reordering and rewording of the new Section C405 {Electrical Power and Lighting Systems (Mandatory)} of the Energy Conservation Code, it is not possible to propose technical amendments for the portion of the legislation beginning on page 2 line 8 and ending on page 3 line 14. To do so would require the Department to interpret, or to presume an understanding of, the sponsors' legislative intent.

# DEPARTMENT OF GENERAL SERVICES PROPOSED AMENDMENT TO CITY COUNCIL BILL 12-0028

# Former Amendment Proposed in April 3, 2012 Bill Response

On page 3, beginning in line 18, insert the phrase "for one receptacle in the sleeping unit(s) dedicated to the charging of electronic devices and" after the word "except" so that it reads:

505.2.3 Sleeping unit controls. Sleeping units in hotels, motels, boarding houses or similar buildings [shall] MUST have at least one master switch at the main entry door that controls all permanently wired luminaires and switched receptacles, except FOR ONE RECEPTACLE IN THE SLEEPING UNIT(S) DEDICATED TO THE CHARGING OF ELECTROINIC DEVICES AND those in the bathroom(s). Suites [shall] MUST have a control meeting these requirements at the entry to each room or at the primary entry to the suite. THESE CONTROLS MUST BE CONFIGURED SO AS TO REQUIRE THE USE OF THE ROOM KEY TO ACTIVATE THE LIGHTING IN THE UNIT OR SUITE.

# New Amendment Proposed Based on Newly Adopted IECC-C Code

**C405.2.3 Specific application controls.** Specific application controls shall <u>MUST</u> be provided for the following:

- 1. Display and accent light shallMUST be controlled by a dedicated control which is independent of the controls for other lighting within the room or space.
- 2. Lighting in cases used for display case purposes shall MUST be controlled by a dedicated control which is independent of the controls for other lighting within the room or space.
- 3. <u>SLEEPING UNITS AND GUEST SUITES IN Hotel and motel sleeping units and guest suites HOTELS, MOTELS, BOARDING HOUSES OR SIMILAR BUILDINGS shallMUST</u> have a master control device at the main room entry that controls all permanently installed luminaires and switched receptacles, EXCEPT FOR ONE RECEPTACLE IN THE SLEEPING UNIT(S) DEDICATED TO THE CHARGING OF ELECTRONIC DEVICES AND THOSE IN THE BATHROOM(S).
- 4. Supplemental task lighting, including permanently installed under-shelf or under-cabinet lighting, shall MUST have a control device integral to the luminaires or be controlled by a wall-mounted control device provided the control device is readily accessible.
- 5. Lighting for nonvisual applications, such as plant growth and food warming, shall MUST be controlled by a dedicated control which is independent of the controls for other lighting within the room or space.
- 6. Lighting equipment that is for sale or for demonstrations in lighting education shall MUST be controlled by a dedicated control which is independent of the controls for other lighting within the room or space.

On page 1, line 8, replace 2013 with 2014 so that it reads:

"... for which a permit application is filed on or after January 1, 20132014."

# Amendment No. 2

On page 1, line 11, add the letter A after the numeral 9 and -C after IECC, and change  $\delta$ 505.2 to \$ C405.2, so that it reads:

"Section(s) 9A-102 (IECC-C § 505.2C405.2)"

## Amendment No. 3

On page 1, line 18, add –A after Roman Numerals IX and – COMMERCIAL PROVISIONS after Code, so that it reads:

# Part IX-A. International Energy Conservation Code – COMMERCIAL **PROVISIONS**

## Amendment No. 4

On page 1, line 19, add the letter A after the numeral 9, so that it reads:

"§ 9A-102. City modifications."

# Amendment No. 5

On page 1, lines 22 and 23, change the numeral 5 to the numeral 4 and add -C after *IECC*, so that it reads:

# "Chapter 54. Commercial Energy Efficiency

[{As in IECC-C}]"

#### Amendment No. 6

On page 2, line 1, change 505 to C405 and add (MANDATORY) after SYSTEMS, so that it reads:

# "SECTION 505C405 ELECTRICAL POWER AND LIGHTING SYSTEMS (MANDATORY)"

#### Amendment No. 7

On page 2, line 2, change 505.1 to C405.1, add (MANDATORY) after General, and add – C after IECC, so that it reads:

# "505.1C405.1 General (MANDATORY) {AS IN IECC-C}"

#### Amendment No. 8

On page 2, lines 3 and 4, change 505.2 to C405.2, add (MANDATORY) after controls, and delete 505.2.1, 505.2.2, 505.2.3 and 505.2.4 and replace with C405.2.1, C405.2.2, C405.2.3, and C405.2.4, so that it reads:

"505.2C405.2 Lighting controls (MANDATORY). Lighting systems [shall] MUST be provided with controls as required in Sections 505.2.1, 505.2.2, 505.2.3, and 505.2.4 C405.2.1, C405.2.2, C405.2.3, and C405.2.4."

On page 2, after line 4, insert the following:

# Amendment No. 10

On page 2, line 5, change 505.2.1 to C405.2.1.1 and add –C after IECC, so that it reads:

"505.2.1C405.2.1.1 Interior lighting controls {AS IN IECC-C}"

#### Amendment No. 11

On page 2 after line 5, insert the following:

## "C405.2.1.2 LIGHT REDUCTION CONTROLS. {AS IN IECC-C}"

#### Amendment No. 12

On page 2, line 6, change 505.2.2 to C405.2.2, add LIGHTING after Additional, and add –C after IECC, so that it reads:

"505.2.2C405.2.2 Additional <u>LIGHTING</u> controls. {AS IN IECC-C}"

#### Amendment No. 13

On page 2, delete the text in line 7:

"505.2.2.1 Light reduction controls. {AS IN IECC}"

Amendment No. 14

On page 3, line 15, change 505.2.2.3 to C405.2.2.3 and add –C after IECC, so that it reads:

"505.2.2.3 C405.2.2.3 Daylight zone control. {AS IN IECC\_C}"

## Amendment No. 15

On page 3, delete lines 16 through 22

"505.2.3 Sleeping unit controls. Sleeping units in hotels, motels, boarding houses or similar buildings [shall] MUST have at least one master switch at the main entry door that controls all permanently wired luminaires and switched receptacles, except those in the bathroom(s). Suites [shall] MUST have a control meeting these requirements at the entry to each room or at the primary entry to the suite. THESE CONTROLS MUST BE CONFIGURED SO AS TO REQUIRE THE USE OF A ROOM KEY TO ACTIVATE THE LIGHTING IN THE UNIT OR SUITE."

# Amendment No. 16

On page 3, line 27, replace 2013 with 2014 so that it reads:

"...for which a permit application is filed on or after January 1, 20132014."
