Honorable President and Members of the City Council

Ladies and Gentlemen:

On July 17, 2013, the Board had before it for consideration the following pending City Council Bills:

- concerning Harbor Point Development Ordinance 13-0232 - An District - Amending Ordinance 10-401 for the purpose of enlarging the boundaries of the development district "Harbor Point Development District" by known as including additional properties; revising Exhibit 1 to properties; deleting and include these additional changing certain parcel references that do not affect the boundaries of the development district; repealing provisions related to state obligations and clarifying certain related provisions; providing for a special generally relating to and date; effective establishment of the Harbor Point Development District.
- 13-0233 An Ordinance concerning Harbor Point Special Taxing District for the purpose of designating a "special taxing district" to be known as the "Harbor Point Special Taxing District;" providing for and determining various matters in connection with the establishment of



the special taxing district; creating a special fund for the special taxing district; providing for the levy of a special tax on all taxable real and personal property located in the special taxing district; providing for a special effective date; and generally providing for matters relating to the designation and the special taxing district, the operation of establishment and use of the special fund, authorizing the pledge of the special tax revenues to the payment by or reimbursement to the City for debt service on any special obligation bonds or notes issued by the City in connection with the special taxing district, the replenishment of any reserve fund, and the payment of certain expenses and administrative costs related to the operation of the special taxing district.

13-0234 - An Ordinance concerning Harbor Point Development - Bond Ordinance for the purpose of authorizing the issuance of special obligation bonds; authorizing the pledge by the City, subject to appropriation, of Tax Increment Revenues and Special Tax Revenues (as such terms are defined herein) to the payment of debt service on such special obligation bonds, the replenishment of any reserves, and the payment of certain expenses and administrative costs; providing that such bonds may be issued from time to time and in one or more issues or series in an aggregate principal amount not exceeding purpose of financing for the \$125,000,000 related costs, improvements and infrastructure including, without limitation, the Project (defined herein), and other necessary improvements to, from, or within the development district, and certain other infrastructure improvements permitted by the Acts (defined herein); providing for the method and sources of payment for such special obligation bonds; providing that the City, in each fiscal year in which any such
