### Recitals

The revenue appropriated by this Ordinance represents funds from surplus State Education
 Trust Fund-Video Lottery Terminal Revenue from Fiscal Year 2013 in excess of the revenue
 relied on by the Board of Estimates in determining the tax levy required to balance the budget for
 Fiscal Year 2014.

# Council Bill 14-0310

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That 1 \$250,000 shall be made available to the Department of Housing and Community Development -2 (Account #9910-905962-9587) as a Supplementary State Fund Capital Appropriation for Fiscal 3 Year 2014, to provide funding for Northwest Neighborhood Improvements activities that include 4 but are not limited to acquisition, relocation, and demolition within the area. The source of 5 revenue for this appropriation is funds from surplus State Education Trust Fund-Video Lottery 6 Terminal Revenue from Fiscal Year 2013 in excess of the amount from this source that was 7 8 relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2014. 9 SECTION 2.
