11 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE**, That 12 permission is granted for the establishment, maintenance, and operation of a convalescent,

13 nursing, and rest home on the property known as 5124 Greenwich Avenue, as outlined in red on

14 the plat accompanying this Ordinance, in accordance with Baltimore City Zoning Code §§ 4-804

15 and 14-102, subject to the condition that the following conditions:

- 16 <u>1.</u> The residential capacity of the facility is 50 beds.
- 172.The convalescent, nursing, and rest home complies must comply with all applicable18federal, state, and local licensing and certification requirements.

SECTION 2. AND BE IT FURTHER ORDAINED, That as evidence of the authenticity of the accompanying plat and in order to give notice to the agencies that administer the City Zoning Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council shall sign the plat; (ii) when the Mayor approves this Ordinance, the Mayor shall sign the plat; and (iii) the Director of Finance then shall transmit a copy of this Ordinance and the plat to the Board of Municipal and Zoning Appeals, the Planning Commission, the Commissioner of
