17	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the
18	Department of General Services shall proceed to condemn and close certain streets and alleys
19	bounded by Guilford Avenue, East 21st Street, Barclay Street, and East 20th Street (Ward 12,
20	Section 12, Block 3806), and more particularly described as follows:
21	Beginning for Parcel Number 5, at a point on the south side of East 20th Street 20
22	feet wide, said point of beginning being distant Westerly 82.0 feet more or less,
23	measured along the south side of said East 20th Street, from the west side of

AND BE IT FURTHER ORDAINED</b> , That the proceedings for the condemnation and closing of certain streets and alleys bounded by Guilford Avenue, East 21 <sup>st</sup> Street, Barclay Street, and East 20 <sup>th</sup> Street and the rights of all interested parties shall be regulated by and in accordance with all applicable provisions of state and local law and with all applicable rules and regulations adopted by the Director of General Services and filed with the Department of Legislative Reference.	
25 26 27 28 29 30 31	<b>SECTION 3. AND BE IT FURTHER ORDAINED</b> , That after the closing under this Ordinance, all subsurface structures and appurtenances now owned by the Mayor and City Council of Baltimor continue to be the property of the Mayor and City Council, in fee simple, until their use has been abandoned by the Mayor and City Council. If any person wants to remove, alter, or interfere with them, that person must first obtain permission from the Mayor and City Council and, in the application for this permission, must agree to pay all costs and expenses, of every kind, arising out of the removal, alteration, or interference.	
32 33 34 35 36 37 38	<b>SECTION 4. AND BE IT FURTHER ORDAINED</b> , That no building or structure of any kind (including but not limited to railroad tracks) may be constructed or erected in or on any part of the street closed under this Ordinance until all subsurface structures and appurtenances owned by the Mayor and City Council of Baltimore have been abandoned by the Mayor and City Council or, at the expense of the person seeking to erect the building or structure, have been removed and relaid in accordance with the specifications and under the direction of the Director of General Services of Baltimore City.	

9	SECTION 5. AND BE IT FURTHER ORDAINED, That after the closing under this Ordinance, all
subs	urface structures and appurtenances owned by any person other than the Mayor and City
Cou	ncil of Baltimore shall be removed by and at the expense of their owners, promptly upon
notio	ce to do so from the Director of Public Works.

**SECTION 6. AND BE IT FURTHER ORDAINED**, That at all times after the closing under this Ordinance, the Mayor and City Council of Baltimore, acting by or through its authorized representatives, shall have access to the subject property and to all subsurface structures and appurtenances used by the Mayor and City Council, for the purpose of inspecting, maintaining, repairing, altering, relocating, or replacing any of them, without need to obtain permission from or pay compensation to the owner of the property.

**SECTION 7. AND BE IT FURTHER ORDAINED**, That this Ordinance takes effect on the date it is enacted.
