#### AN ORDINANCE CONCERNING

1	Floodplain Management Code – Revision
2	FOR the purpose of modifying the City laws governing floodplain management to meet or exceed
3	requirements for eligibility in the National Flood Insurance Program and other requirements
4	of Federal and State law; incorporating certain flood-resistant design and construction
5	standards adopted by the American Society of Civil Engineers; defining and redefining
6	certain terms; repealing redundant, obsolete, or otherwise superfluous provisions; correcting
7	and conforming certain obsolete nomenclature; providing for alternative enforcement
8	procedures; providing for administrative and judicial reviews of administrative actions;
9	providing for a special effective date; and generally relating to the protection, maintenance,
10	and enhancement of the public health, safety, and welfare through floodplain management.

20 21	"Base flood" means a flood that has a 1% chance of being equaled or exceeded in any given year.
22	(E) [(b-1)] Base-flood elevation.
23	(1) IN GENERAL.
24 25	"Base-flood elevation" means the water surface elevation of the base flood in relation to the datum specified on the [Baltimore City] Flood Insurance Rate Map.

1	(2) Areas of shallow flooding.
2 3 4	In areas of shallow flooding, "base-flood elevation" means the highest [adjacent] natural [grade] elevation OF THE GROUND SURFACE, PRIOR TO CONSTRUCTION, THAT IS ADJACENT TO THE PROPOSED FOUNDATION OF A STRUCTURE; plus:
5	(i) the depth number specified in feet on the Flood Insurance Rate Map; or
6	(ii) [4 feet] if the depth number is not specified, 4 FEET.
7	(F) [(c)] <i>Basement</i> .
8	"Basement" means any area of a [building] STRUCTURE having its floor subgrade (below ground level) on all sides.
10	[(d) Break away wall.]
11	[(1) "Break away wall" means a wall that:
12	(i) is not part of the structural support of the building; and
13 14 15	<ul><li>(ii) is intended through its design and construction to collapse under specific lateral loading forces, without causing collapse, displacement, or other structural damage to the elevated portion of the building or supporting foundation system.]</li></ul>
17 18 19 20	[(2) For the purposes of this definition, a break away wall shall have a design safe loading resistance of not less than 10 and no more than 20 pounds per square foot. Such enclosed space shall be no lower than grade and shall be usable solely for parking of vehicles, building access, or storage. If a separate storage area is provided at grade, such area shall not exceed 300 square feet.]
22 23 24 25 26 27	[(3) Break away walls which exceed the above stated safe loading resistance may be permitted only if a registered professional engineer or architect certifies that the wall shall collapse under a force less than that exerted by a 100-year storm in this region without jeopardizing the structural integrity of the supporting foundation. When the design safe loading resistance exceeds 20 pounds per square foot, but is certified to collapse under a force less than that exerted by the 100-year storm, the designed resistance must be stated clearly and certified independently on the building plans.]
29 30 31	[(4) The 100-year storm means the storm which causes that level of flooding, water loads wind speeds, duration, direction and forces which, when acting simultaneously, result in severe beach erosion and overwash and have a 1% chance of occurring each year.]

27	(2) BY WHOM AND HOW PREPARED.
28 29 30	AN ELEVATION CERTIFICATE MAY ONLY BE PREPARED AND CERTIFIED BY A LICENSED LAND SURVEYOR, using Mean Sea Level as established by the North American Vertical Datum of 1988 ("NAVD").

1	(L) [(f-1)] Fair market value.
2	(1) IN GENERAL.
3 4 5	"Fair market value" means the price at which property will change hands between a willing buyer and a willing seller, neither of which is under compulsion to buy or sell and both of which have reasonable knowledge of relevant facts.
6	(2) BY WHOM DETERMINED.
7 8	For purpose of this Division I, the fair market value of a [building] STRUCTURE is determined by:
9	(i) a licensed real estate appraiser; or
10 11	(ii) the most recent, fully phased-in assessed value of the [building] STRUCTURE, as determined by the Maryland Department of Assessments and Taxation.
12	(M) FEMA.
13	"FEMA" MEANS THE FEDERAL EMERGENCY MANAGEMENT AGENCY.

6	"Flood Insurance Study" OR "FIS" means [an analysis of hydrologic and hydraulic
7	conditions in streams and tributaries used to determine flood elevations and frequency
8	THE OFFICIAL REPORT IN WHICH THE FEDERAL EMERGENCY MANAGEMENT AGENCY HAS
9	PROVIDED FLOOD PROFILES, FLOODWAY INFORMATION, AND WATER SURFACE

11	(U) [(j)] Flood-protection elevation.
12	"Flood-protection elevation [(FPE)]"means the [elevation of the base flood] MINIMUM
13	ELEVATION REQUIREMENTS OF ASCE 24, plus [1 foot] freeboard.
14	(V) [(k)] Floodplain.
15	"Floodplain" means:
16 17	(1) a relatively flat or low land area adjoining a river, stream, or watercourse [which] THAT is subject to partial or complete inundation;
18 19	(2) an area subject to the unusual and rapid accumulation or runoff of surface waters from any source; or
20	(3) an area subject to tidal surge or extreme tides.
21	(W) FLOODPLAIN DISTRICT.
22	"FLOODPLAIN DISTRICT" MEANS THE DISTRICT, AND ITS CONSTITUENT SUBDISTRICTS,

2 3	FOR PURPOSES OF THIS DIVISION I, THE TWO METHODS OF FLOODPROOFING ARE AS FOLLOWS:

3 4 5 6	"Floodway" means the channel of a river or other watercourse and the adjacent land areas that are reserved to pass a base-flood discharge so that the cumulative increase in the water surface elevation of the base-flood discharge is no more than a designated height.
7	(2) HOW SHOWN ON FIRM.
8 9	When shown on a FIRM, the [floodway] FLOODWAY is referred to as the "designated floodway".
10	(3) Considered high-velocity-flow area.

19	(F) FUNCTIONALLY DEPENDENT USE.
20	(1) IN GENERAL.
21 22 23	"Functionally dependent use" means, except as otherwise provided in this subsection, any of the following uses that cannot perform their intended purposes unless located or carried out in close proximity to water:
24 25	(I) DOCKING FACILITIES THAT ARE NECESSARY FOR THE LOADING AND UNLOADING OF CARGO OR PASSENGERS; AND
26	(II) SHIP BUILDING AND SHIP REPAIR FACILITIES.
