8	conforming related language; providing for a special effective date; and generally relating to
9	the functions, powers, and duties of the Committee on Legislative Investigation.

9 10	(I) THE COMMITTEE MAY PETITION THE CIRCUIT COURT OF BALTIMORE CITY TO ORDER COMPLIANCE WITH THE SUBPOENA; AND
11	(II) ON PETITION, THE COURT MAY:
12 13	(A) PASS AN ORDER DIRECTING COMPLIANCE WITH THE SUBPOENA OR COMPELLING TESTIMONY; AND
14	(B) ENFORCE ITS ORDER BY PROCEEDINGS FOR CONTEMPT.
15 16	(2) FALSE SWEARING BY A WITNESS BEFORE THE COMMITTEE IS SUBJECT TO THE PENALTIES OF PERJURY.

18 19	(1) THE COMMITTEE MAY ADOPT RULES TO GOVERN ITS PROCEDURES UNDER THIS SECTION, INCLUDING THE CONDUCT OF HEARINGS UNDER THIS SECTION.
