20	PARKING IS RESTRICTED AT ALL TIMES.
21	(C) PARKING DURATION.
22 23	(1) EXCEPT ONLY AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, NO PARKING IS PERMITTED FOR NON-PERMIT HOLDERS.
24	(2) THIS SUBSECTION DOES NOT APPLY TO A COMMERCIAL VEHICLE THAT:
25 26	(I) IS PARKED FOR PURPOSES OF MAKING A DELIVERY OR PROVIDING A SERVICE TO A PERSON IN THE AREA; AND
