## Johns Hopkins South of Orleans Business Planned Unit Development

- 3. All intended use of the property: <u>The amendment will permit the construction of the proposed Skip Viragh Cancer Center.</u> The proposed changes to the PUD are as follows:
  - 1. Reallocate the permitted density on each section of the site without increasing the aggregate permitted density for the entire site by means of:
    - a. Decreasing the permitted density on the eastern section of the site (Area
       A) from 150,000 to 95,000 gross square feet to conform to the density of the building already constructed;
    - b. *Increasing* the permitted density on the western section of the site (Area C) from 200,000 gross square feet to 230,000 gross square feet;
    - c. *Increasing* the permitted density of the central portion of the site (Area B) from 500,000 gross square feet to 530,000 gross square feet;
  - 2. Modify the bulk restrictions on the western portion of the site (Area C) by:
    - a. Modifying the height restriction of 90' above the datum point for the first 40' of site depth along the Broadway and Fayette street frontages to zero feet;
    - b. Reducing the maximum height limitation above the datum point from 160' to 150'; and
    - c. Allowing the southern 165' of the western section of the site fronting Broadway to be built out to a maximum height of 150'; and
  - 3. Modify the bulk restrictions on the central portion of the site (Area B), increasing the maximum building height from 160' to 190' above the site datum point.
