11 SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That

12 permission is granted for the establishment, maintenance, and operation of a banquet hall and

13 dance hall on the property known as 720 Mapleton Avenue, as outlined in red on the plat

- accompanying this Ordinance, in accordance with Baltimore City Zoning Code §§ 6-409(1) and
- 15 14-102, subject to the condition that the <u>following conditions:</u>
- For events held on any night of the week, the banquet hall and dance hall must close no later than 5:00 a.m.
 During events, adequate security personnel must be present in and around the banquet hall and dance hall.
 The banquet hall or dance hall operator or designee must immediately report any loitering on or about the property to the Baltimore City Police Department and must

cooperate in any way possible to facilitate resolution of complaints.

3 SECTION 2. AND BE IT FURTHER ORDAINED, That as evidence of the authenticity of the accompanying plat and in order to give notice to the agencies that administer the City Zoning 4 Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council 5 shall sign the plat; (ii) when the Mayor approves this Ordinance, the Mayor shall sign the plat; 6 7 and (iii) the Director of Finance then shall transmit a copy of this Ordinance and the plat to the 8 Board of Municipal and Zoning Appeals, the Planning Commission, the Commissioner of 9 Housing and Community Development, the Supervisor of Assessments for Baltimore City, and 10 the Zoning Administrator.
