16	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the
17	Department of General Services shall proceed to condemn and open the Air Rights area over a
18	portion of Lovegrove Street, extending northerly 100 feet from the north side of East Lanvale
19	Street, and more particularly described as follows:
20	Beginning for the same at a point on the north side of East Lanvale Street 66
21	feet wide and the west side of Lovegrove Street 20 feet wide, the point of
22	beginning being distant easterly 184.66 feet from a point formed by the
23	intersection of the east side of North Charles Street and the north side of East
24	Lanvale Street, the point also being in a horizontal plane having an elevation of
25	95.69 feet, as referenced to the Baltimore City Vertical Datum, running thence the
26	following courses and distances:
27	1. Northerly for a distance of 100.0 feet binding on the west side of
28	Lovegrove Street; thence

7 8 9	This parcel defines the limits of an air right parcel having a lower elevation of 95.69 feet as referenced to the Baltimore City Vertical Datum and extending to an elevation of unlimited height.
