BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That, in accordance with Article V, § 5(b) of the City Charter, the City Comptroller may sell, at either 15 public or private sale, all the interest of the Mayor and City Council of Baltimore in the air rights 16 area over a portion of a 10-foot alley in the rear of 435-439 East Lafayette Avenue, extending 17 westerly 56 feet, more or less, from Greenmount Avenue, and more particularly described as all 18 19 that land lying above at an elevation of 112.00 feet (Baltimore City Vertical Datum) and 20 contained within the following metes and bounds, to wit:
