AN ORDINANCE CONCERNING

1 Planned Unit Development – Amendment 1 – Johns Hopkins South of Orleans 2 FOR the purpose of approving certain amendments to the Development Plan of the Johns 3 Hopkins South of Orleans Planned Unit Development. By authority of 4 5 Article - Zoning Title 9, Subtitles 1 and 4 6 Baltimore City Revised Code 7 (Edition 2000) 8 9 Recitals By Ordinance 03-492, the Mayor and City Council (i) approved the application of Broadway 10 Acquisition and Development Series ("Broadway Acquisition") to have the property located at 11 201 North Broadway and 301 North Broadway (collectively, the "Property"), consisting of 7.362 12 acres, more or less, designated as a Business Planned Unit Development and (ii) approved the 13

Johns Hopkins Medicine, an affiliate of Broadway Acquisition (the "Developer") wishes to amend the Development Plan, as previously approved by the Mayor and City Council.

On April 2, 2014, representatives of the Developer met with the Department of Planning for a preliminary conference to explain the scope and nature of the proposed amendments to the Development Plan.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Mayor and City Council approves the application of [Broadway Acquisition and Development Series, fee simple owner of the property located at 201 North Broadway and the contract purchaser of 301 North Broadway,] THE DEVELOPER FOR THE PROPERTIES LOCATED AT 201 NORTH BROADWAY AND 301 NORTH BROADWAY, consisting of 7.362 acres, more or less, as outlined on the accompanying Development Plan consisting of:

27 28 29	SECTION 2. AND BE IT FURTHER ORDAINED , That all plans for the construction of permanen improvements on the property are subject to final design approval by the Planning Commission to insure that the plans are consistent with the Development Plan and this Ordinance.
30 31 32	SECTION 3. AND BE IT FURTHER ORDAINED , That the Planning Department may determine what constitutes minor or major modifications to the Plan. Minor modifications require approval by the Planning Commission. Major modifications require approval by Ordinance.
33 34 35 36 37 38 39	SECTION 4. AND BE IT FURTHER ORDAINED , That as evidence of the authenticity of the accompanying amended Development Plan and in order to give notice to the agencies that administer the City Zoning Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council shall sign the amended Development Plan; (ii) when the Mayor approves this Ordinance, the Mayor shall sign the amended Development Plan; and (iii) the Director of Finance then shall transmit a copy of this Ordinance and the amended Development Plan to the Board of Municipal and Zoning Appeals, the Planning Commission, the
