13	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the

18	§ 6-26. Solicitation prohibited.			
19	(a) In general.			
20	Except as permitted under subsection (b) of this section, a public servant may not solicit			
21	or facilitate the solicitation of a gift, whether on the public servant's own behalf or on			
22	behalf of another person, from any person that the public servant knows or has reason to
