18	"Property of CSX Transportation, Inc. & the Baltimore Sun & The Mayor and		
19	City Council of Baltimore", recorded among the Land Records of Baltimore City,		
20	Maryland on January 29, 1996, in Pocket Folder S.E.B. 3511.		
21	This property being no longer needed for public use.

23	unless the deed has been approved by the City Solicitor.
