1	Part 4. Administrative Sanctions
2	§ 1-28. Denial, suspension, or revocation.
3	(a) In general.
4 5	The Board may deny, suspend, or revoke an adult-entertainment business license or renewal license for any of the following causes:
6	(1) failing to pay the applicable license fee on or before the due date;
7 8	(2) making any material false statement in any application for an initial or renewal license;
9	(3) lack of accessibility for fire and police protection;
10 11	(4) failing to comply with any provision of the City Building, Fire, and Related Codes Article, Health Code Article, or Zoning Code Article;
12 13	(5) failing to comply with any provision of this subtitle or of any rule or regulation adopted under this subtitle; or
14 15	(6) failing to comply with any provision of any other local, state, or federal law that affects or relates to the operation of the adult-entertainment business.
16	§ 1-29. Fines.
17 18	For any violation that is cause for suspending or revoking a license, the Board may, instead of or in addition to suspending or revoking the license, impose a civil fine of:
19	(1) for a 1^{st} offense, not more than \$500; and
20	(2) for any subsequent offense, not more than \$1,000.
21 22 23	SECTION 2. AND BE IT FURTHER ORDAINED , That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day
 after the date it is enacted.
