#### Zoning – Conditional Use Conversion of 2 Dwelling Units to 3 Dwelling Units in the R-8 Zoning District – Variances – 844 North Carey Street

- FOR the purpose of permitting, subject to certain conditions, the conversion of 2 dwelling units to
  3 dwelling units in the R-8 Zoning District on the property known as 844 North Carey Street,
  as outlined in red on the accompanying plat; and granting variances from certain lot area size,
  off-street parking, and floor area ratio requirements.

### 13 SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That

14 permission is granted for the conversion of 2 dwelling units to 3 dwelling units in the R-8 Zoning

15 District on the property known as 844 North Carey Street, as outlined in red on the plat

16 accompanying this Ordinance, in accordance with Baltimore City Zoning Code §§ 3-305(b) and 17 14-102, subject to the condition that the building complies with all applicable federal, state, and

- 18 local licensing and certification requirements.
- 19 SECTION 2. AND BE IT FURTHER ORDAINED, That pursuant to the authority granted by Title 20 15 of the Zoning Code of Baltimore City, specifically by §§ 15-101, 15-202(a), and 15-218,
- 21 permission is granted for a variance of 23.1% for lot area size.

SECTION 3. AND BE IT FURTHER ORDAINED, That pursuant to the authority granted by Title 15 of the Zoning Code of Baltimore City, specifically by §§ 15-101, 15-214, 15-218, and 15-219, permission is granted for a variance from the requirements of the Zoning Code of Baltimore City for off street parking

25 for off-street parking.

SECTION 4. AND BE IT FURTHER ORDAINED, That pursuant to the authority granted by Title for the Zoning Code of Baltimore City, specifically by §§ 15-101, 15-204, and 15-218, permission is granted for a variance that is more than otherwise allowed by the applicable regulation, for floor area size.

5 SECTION 5. AND BE IT FURTHER ORDAINED. That as evidence of the authenticity of the accompanying plat and in order to give notice to the agencies that administer the City Zoning 6 Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council 7 8 shall sign the plat; (ii) when the Mayor approves this Ordinance, the Mayor shall sign the plat; and (iii) the Director of Finance then shall transmit a copy of this Ordinance and the plat to the 9 Board of Municipal and Zoning Appeals, the Planning Commission, the Commissioner of 10 Housing and Community Development, the Supervisor of Assessments for Baltimore City, and 11 the Zoning Administrator. 12

SECTION 6. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
