

We are herein reporting on City Council Bill 16-0763, the purpose of which is to amend Article 14, Section(s) 11-7(a) of the Baltimore City Code; to add a new Section(s) 11-23 (d), the purpose of which is to alter the collection period of the license fee for the York Road Retail Business District from annual to semiannual.

Background

Retail Business District License (RBDL) areas are City-defined commercial districts in which all businesses pay an annual fee, collected by the Department of Finance – Bureau of Revenue Collections (BRC), that is then used by the respective local business associations for marketing, promotions, beautification, and special events. City Council enacts the ordinances defining the boundaries, fee amounts, and collection period for each of the City's ten RBDLs. Each District has a different fee rate and method of calculation, but all Districts are currently billed annually. The Department of Finance – Bureau of Accounting and Payroll Systems (BAPS) charges each District 3% of its RBDL balance for the collection and accounting of this fee. Revenue from the 3% charge supports the City's General Fund and is meant to offset BRC staff operating costs. The table below summarizes the last three fiscal years of collected RBDL General Fund revenue:

The BRC individually invoices businesses in each of the ten RBDL areas by December, with full payment due no later than January 1st of the following calendar year. As the number of businesses in any given District can fluctuate over time, the invoicing phase is initiated by a pre-inventory walk conducted by Baltimore Development Corporation (BDC) staff, beginning in late September and ending in early November. The table below summarizes the number of identified businesses in each District-FY2016.

In addition to the pre-inventory walk, BDC and BRC staff conduct a pre-lawsuit inventory walk, beginning in late January and ending the first week of March, in order to hand-deliver delinquency notices to noncompliant business owners. The Baltimore City Law Department and BRC use this information for potential court filings and processing. The Department of Finance defers to BDC and Law for these agencies' respective analyses of the proposed bill's operating impact.

Analysis

The License Unit of the Bureau of Revenue Collections will issue a bill for a semi-annual license to the 224 businesses in the York Road/Govanstowne district and the licenses will be issued in January, 2017 to those businesses that pay the license fee, as requested in Council Bill 16-0763. In July of 2017, once the RBDL for the Govanstowne Business Association has converted, an annual Business Improvement District bill will be mailed to the 224 districts in the York Road Govanstowne district. Mailing a semi-annual license will reduce the double billing that would have occurred if an annual license fee had been charged and distributed in January of 2017.

Conclusion

The Department of Finance supports Council Bill 16-0763.
