



The Department of Housing and Community Development (HCD) has reviewed City Council Bill 18-0259, for the purpose of amending the City Fire Code to repeal Appendix D {"Fire Apparatus Access Roads"}; and providing for a special effective date.

If enacted, this bill would amend the City Fire Code to remove Appendix D (Fire Apparatus Access Roads), which was designed as a tool for local jurisdictions to use as guidance in establishing fire equipment access requirements. Appendix D provides additional detailed information that supports the information in Chapter 5 (Fire Service Features), Section 503 (Fire Apparatus Access Roads) of the City Fire Code.

HCD is aware that recent changes to the Fire Department's enforcement of the minimum width provisions in the Fire Code have resulted in a dampening influence on development and the creation of design constraints for many projects throughout the City.

HCD is supportive of the need to develop an approach for balancing development with the need for public safety and the ability to provide adequate emergency services for residents that does not represent unrealistic standards for an older City.

The Department of Housing and Community Development does not support the bill in its current form and would recommend that amendments to the Bill be developed through a deliberative inclusive process to satisfy critical implementing agencies, such as the Departments of Housing, Planning, Transportation, and the Baltimore City Fire Department.

Dear President and City Council Members:

The Law Department has reviewed City Council Bill 18-0259 for form and legal sufficiency. The bill provides for amending the City Fire Code to repeal Appendix D ("Fire Apparatus Access Roads." Although the bill eliminates one reference to the provisions of the IFC regarding "Fire Access Roads," Chap. 5 of the Fire Code also provides for regulation of fire access roads and incorporates certain provisions of the IFC on that subject.

The Mayor and City Council the power, by ordinance, to provide for protection against fires, and to establish and to regulate all matters relating to a Fire Department. Baltimore City Charter Art. II, Sec.7(a). In addition, the Public Safety Art. of the Md. Ann. Code, Sec.6-401 specifically exempts Baltimore City from State fire regulations except with respect to State property, hospitals, nursing homes etc. and sprinkler contractors. This bill is, therefore, consistent with the City's authority.



Appendix D of the International Fire Code (IFC) provides additional guidance on the design and layout of fire apparatus roads and requirements for enforcement. The regulations regarding Fire Apparatus Access are found in Chapter 5 of the IFC. The City of Baltimore has adopted the 2015 edition of the IFC,; with the exception of Appendices A, C, I, J, K, L, and M.

The Baltimore City Fire Department does not recommend repealing Appendix D of the 2015 edition of the International Fire Code because Appendix D provides guidance for public safety and firefighting and rescue operations in all of the following areas:

- •Allows for proper positioning of fire apparatus at fire scenes for fire suppression and rescue operations (options available for attacking a fire increase as more of a building's perimeter are accessible to fire apparatus);
- •Provides for adequate road widths, grade, clearances, lengths, turning radius, for fire apparatus in proximity to commercial buildings, hydrants, facilities, multi-family dwelling units, multi-family projects and one or two family residential dwellings for fire suppression and rescue activities;
- •Allows for the provision of fire access routes to minimize factors that could inhibit access to buildings such as terrain, traffic, parking, barriers and vehicle congestion;
- •Provides for a means for fire apparatus to turn around in various street designs including dead ends, cul-de-sacs and other configurations;
- •Provides for road width for roads designated as fire apparatus access roads;
- •Provides for the placement of NO PARKING and FIRE LANE signs on fire apparatus access roads;

- •Provides for two means of access to all buildings and facilities exceeding 30 feet or three stories in height and buildings exceeding 62,000 square feet; and
- •Prescribes gate sizes, locations, swing and locking specifications on fire access roads

In the Department's professional and technical opinion, we believe that the repeal of Appendix D of the IFC would have a detrimental impact on overall public safety. We also believe that the repeal of Appendix D would impact the operations not only of BCFD, but also law enforcement vehicles and other public services (such as trash trucks, public utility vehicles, etc.).

Major Issues Discussed

June 19, 2018 Hearing

- 1. Chairman Costello opened the proceedings and introduced the committee members in attendance.
- 2. Councilman Dorsey summarized the bill and why it was needed.
- 3. Chairman Costello reviewed the agency recommendations. The Law Department approved the bill for form and legal sufficiency. The Department of Housing and Community Development indicated that it did not support the bill and recommended a collaborative effort to develop amendments. The Fire Department opposed the bill.
- 4. The Fire Department explained that it does not oppose bike lanes, but was concerned that changing the Fire Code in this way could inhibit its ability to respond to emergencies.
- 5. Councilman Bullock asked what the potential compromise position between the bill and the Fire Department would look like. The Fire Department indicated that it has the authority to deviate from the Fire Code after considering public safety and the specific circumstances, and that that approach is better than a one size fits all approach.
- 6. Councilman Bullock asked if there were examples of road widths preventing Fire Department response in an emergency. The Fire Department responded that it is hard to know because a variety of circumstances often cause the Fire Department to deviate from the most direct route, but narrow roads have probably resulted in some delays.
- 7. Councilwoman Clarke asked for additional explanation on Appendix D and its history in the Baltimore Fire Code. The Fire Department provided additional background.
- 8. Councilwoman Clarke asked what the Fire Department does on roads that do not meet the Fire Code minimums. The Department noted that many roads in Baltimore do not meet the minimums, and stated that it does what it can to respond to emergencies in any circumstances. It further noted that the requirements in Appendix D will help prevent the narrowing of roads that currently meet the minimums.
- Councilman Scott asked if making this change to the Fire Code could expose the City to new/increased liability. The Law Department said it would have to do additional research to provide an answer.
- 10. Councilman Dorsey commented that the Appendices to the International Fire Code, including Appendix D, are clearly optional and intended to be adopted or not based on local circumstances. He also stated that removing Appendix D will not require the City to build roads differently than it does currently.

- 11. Councilman Pinkett asked the Department of Housing and Community Development to explain how Appendix D impacts the housing code. The Department explained that it relies on the Fire Department for part of its permitting review for projects, and Appendix D affects that review.
- 12. Councilman Dorsey proposed amendments to the bill.
- 13. The Fire Department stated its preference for a more holistic and planned approach to revising the Fire Code.
- 14. Members of the public testified in support of the bill, and stated that Appendix D is more appropriate for suburban settings than older cities like Baltimore and that repealing Appendix D will contribute to economic development and public safety. Some also noted that the Fire Code is being applied unevenly to certain projects and issues, and that while the law has not changed the Fire Department has recently changed how it is applying it.
- 15. Other members of the public, including Fire Fighter union representatives, testified in opposition to the bill. They stated that the bill could allow the narrowing of roads that currently meet the standards, possibly resulting in difficulty rescuing people from buildings in emergencies.
- 16. Chairman Costello recessed the hearing and announced that the Committee would reconvene for a Work Session on the bill at 4:50 PM on Wednesday, June 20, 2018. Chairman Costello also asked the agencies to come to the Work Session prepared to address specific issues (see Further Study), and noted that the Committee would not hear additional public testimony at the Work Session.

June 20, 2018 Work Session

- 1. Chairman Costello opened the proceedings and introduced the committee members in attendance.
- The Fire Department presented its evaluation of the amendment proposed by Councilman Dorsey. The Department stated that the National Association of City Transportation Officials Urban Street Design Guide is not a code book, which would make it challenging to implement as part of the Fire Code.
- 3. Councilman Dorsey asked if the Fire Department has ever required the removal of on-street parking to meet the Fire Code minimums. The Fire Department said it has not.
- 4. Councilman Stokes asked how many projects are currently awaiting Fire Department approval, and for the average turnaround time for the Fire Department to approve projects. The Department said it would need time to provide that information.
- 5. Council President Young asked why the Fire Department has seemingly changed its practices as they relate to Appendix D, and if the Fire Department can withdraw its approval for development projects that went through the City Council after the Council has approved. The Law Department responded that it would depend on the Fire Department's role in the initial approval.
- 6. The Law Department stated that this bill would not likely lead to any new or increased liability for the City, but the issue is complex. The Law Department also provided a written response (see attached).
- 7. The Finance Department indicated that this bill would not impact the City's bond rating.
- 8. The Committee considered and adopted amendments to the bill.
- 9. Chairman Costello stated that the City Council would delay final action on the bill if the Fire Department made a good faith effort to resolve the issues related to its implementation of Appendix D and related Fire Code provisions (see Further Study).

Dear President and City Council Members:

At the June 18th hearing on the above captioned bill, the Law Department was asked to review the amendment proposed by Councilman Dorsey, research the City's liability should this bill pass and assess the bill's impact and the bill's impact on the City's bond rating

The amendment proposed by Councilman Dorsey would create an exception to 503.2.1 of the Fire Code and require that public streets have dimensions in accordance with the NACTO Urban Street Design Guide, The amendment does not strike the existing Chapter 5 provisions regarding dimensions or the authority of the fire code official to require or permit modifications to the required access widths where they are inadequate for fire or rescue operations. The ability to retain necessary access for emergency vehicles is preserved.

Even if Appendix D is repealed, the City would not be liable, because in doing so, it is exercising a governmental function, a discretionary exercise of police power, and is immune from liability. 18 McQuillin Mun. Corp. §53:66 (failure to pass a needed law or the repeal of an ordinance is a legislative function and the government cannot be liable). Although there is an exception to this immunity rule for the maintenance and control of streets, those cases are distinguishable because they deal with failure to repair traffic signals or placing of warning signs on road of dangers and not the establishment of policy that involves the exercise of discretion. See, e.g. Montgomery County v. Voorhees, 86 Md. App. 294 (1991). The repeal of a law concerning the width of streets is factually different than failing to maintain traffic signals or failing to repair street defects. In addition, there is also an exception to the immunity for constitutional torts, however, repealing a law is never a constitutional tort, so liability would not rise from the act itself. Town of Port Deposit v. Petetit, 113 Md. App. 401 (1997) (when a municipality is performing a governmental function, it is not committing a constitutional tort). Finally, the failure of the government to recommend the "best" practice for fire safety cannot give rise to liability because it is an exercise of police power and to hold the government liable for not making the best decision would be a "crushing" burden for governments to bear. Shaw v. Village of Hampstead, 177 N.Y.S. 2d 744 (1958).

Finally, after consultation with bond council, this will not be a consideration when determining the City's bond rating.

I'm writing to offer some thoughts following yesterday's hearing regarding the above referenced bill.

Bond Rating

During yesterday's hearing a claim was made by a gentleman affiliated with the Fire Department that deleting appendix D could negatively impact the City's bond rating. Having some experience with municipal bonds I reached out to two professionals in the municipal bond industry who collectively have done hundreds of municipal bond deals across the country and in Baltimore. One of them reached out to her contacts at the rating agencies.

The rating agency analyst was very clear that level of fire service, fire response times, and fire codes are NOT part of the criteria they use to analyze the City's credit worthiness/bond rating. Further, all of them indicated that in all of their bond deals there has never been a discussion regarding level of fire service, response times, and fire codes. They all said it's not relevant.

All three indicated that the City's overall economic health is the key driving factor of its bond rating, and that includes the ability to generate economic development and economic growth

Bike Lanes/Safe Streets

Many of my colleagues and I in Baltimore's economic development community support bike lanes, alternative means of transportation and complete streets. These things are important to the communities we build. For example, as I walked into my office building this morning (Morgan Stanley building in Harbor Point) there were three dozen bikes parked in front of the building and a similar number parked at the Exelon Building.

That said, too much of yesterday's testimony focused on bike lanes and not enough focused on the need for well-designed streets that balance fire safety with the safety of motorists, pedestrians and cyclists. The risk of accident and injury on our streets is greater than the risk of injury due to fire, as fire incidents have decreased over the years. Making streets even wider — as strict adherence to the suburban focused IFC would require — makes our streets more dangerous and does so without improving fire safety, as BCFD has shown for years that it can operate very effectively and safely within the confines of Baltimore's existing street network.

Until one year ago, the balance between fire safety, economic development, and street design functioned relatively well. I hope the Council will help restore the City to this balance.

Dear Council President and Council Members -

I was unable to reach some of you by phone today so I've put my thoughts in writing. Below is my testimony in support of City Council Bill 18-0259

Since my days chasing Engine 43 across north Baltimore on my 3 speed Schwinn, I've had a great fondness and respect for Baltimore City Fire Department and the women and men who are its heart and soul. That fondness and respect has grown as I've witnessed their excellence and professionalism in action.

That said, I am writing to support Council Bill 18-0259 to amend the City Fire Code by repealing Appendix D of the 2015 International Fire Code and to encourage you to vote in favor of this bill.

Appendix D of the International Fire Code – particularly the 26' clearance rule – will have the following negative impacts on Baltimore -

- 1. Cost the City of Baltimore more money,
- 2. Inhibit economic development
- 3. Result in roads that are less safe.
- 4. Negatively impact Baltimore's environment

Costs

Implementation of the 26' clearance rule will require some developments to build wider roads. Simply put, wider roads are costlier to build and wider roads are costlier to maintain. Those costs are borne by City taxpayers. But they are costs that can be avoided by applying good, sensible and time tested urban design practices.

Safety

Wider roads result in higher travel speeds and higher travel speeds result in a greater number of motor vehicle accidents. Further, accidents at higher speed result in more serious injuries and more deaths. Appendix D makes streets less safe for motorists, pedestrians, and cyclists because it increases the average rate travel speeds and thus increases the risk of motor vehicle related accidents.

Economic Development

Growth and economic development are critical for most cities but more so for Baltimore given the loss of residents and businesses over the past 60 years and the related damage done to the City's general fund. The regulations set forth in Appendix D threatens to stifle economic development. Based on numerous discussions, I can report that my colleagues in the economic development community are very concerned that the that projects on their drawing boards — projects this city needs — will no longer be feasible under Appendix D and will need to be cancelled or significantly altered. Some examples are -

Charles Village - a \$14.0 m privately, funded investment in street and streetscape improvements has been on hold since January 2018. Those improvements will enhance the safety of pedestrians, motorists, and cyclists while creating a more vibrant and welcoming public streetscape which is vital to a healthier, more robust and sustainable commercial district.

Without relief from Appendix D regulations, the project will either have to be modified so that it will no longer provide the daily safety enhancements to pedestrians, motorists and cyclists or it will have to be cancelled entirely.

EBDI – the Townes at Eager Park – 34, 3 story townhouses with a total development cost of \$10.0 m is currently delayed.

Perkins/Somerset/Oldtown – the \$850 m redevelopment in East Baltimore includes new streets, sidewalks, and streetscaping. The 26' clearance requirement will require us to build larger, more expensive streets putting additional budgetary pressure on a project that is intended to provide a significant amount of affordable housing.

Environment

Wider streets equal more impervious surface and more polluted surface runoff into the region's waterways. Increased runoff to the storm drains will only worsen the combined sewer overflow problem that is sending

hundreds of thousands of gallons of untreated sewage into the harbor every year. This could impact the City's ability to comply with its MS4 permit from the US Environmental Protection Agency.

Streets are not simply spaces for cars, buses, and trucks. They are places for people to connect. They are the connective public tissue that binds together the private urban fabric of homes, places of worship, offices, and shops. We need to design our streets for all users but we also must balance that design with the perspectives of multiple users. We need complete streets that are designed by urban designers with input from all users.

ANALYSIS

Current Law

Part VIII of the Building, Fire, and Related Codes of Baltimore City adopts the International Fire Code (2015 Edition) ("IFC") subject to certain additions, deletions, amendments, and other modifications. Chapter I, § 101.2.1 lists the appendices to the IFC adopted by Baltimore City, including Appendix D (Fire Apparatus Access Roads). Chapter I, § 101.2.2 lists the appendices that Baltimore City has not adopted.

Appendix D of the IFC expands on the basic requirements for fire apparatus access roads found in Section 503 of the IFC. Appendix D notes that it is "not mandatory unless specifically referenced in the adopting ordinance."

Part VIII, Chapter 5 of the Building, Fire, and Related Codes of Baltimore City adopts § 503 of the IFC. Section 503 contains the basic requirements for fire apparatus access roads, and requires "[a]pproved fire apparatus access roads ... for every facility, building or portion of a building hereafter constructed or moved into or within the jurisdiction." Among other requirements, § 503 states that "[f]ire apparatus access roads shall have an unobstructed width of not less than 20 feet (6096 mm), exclusive of shoulders..."

Bill Summary

This bill amends Part VIII of the Building, Fire, and Related Codes of Baltimore City to remove Appendix D (Fire Apparatus Access Roads) from the list of appendices to the IFC adopted by Baltimore City and to add Appendix D to the list of appendices that Baltimore City has not adopted.


