BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That permission is granted for the conversion of a single-family dwelling unit to 2 dwelling units in 15 the R-8 Zoning District on the property known as 417 East Lafayette Avenue (Block 1104, Lot 16 17 024), as outlined in red on the plat accompanying this Ordinance, in accordance with Baltimore City Zoning Code §§ 5-201(a) and 9-701(2), subject to the condition that the building complies 18 with all applicable federal, state, and local licensing and certification requirements. 19

20 **SECTION 2.** AND BE IT FURTHER ORDAINED. That pursuant to the authority granted by §§ 5-201(a), 5-305(a), and 5-308, of Article 32 - Zoning, permission is granted for a variance from the 21 22 off-street parking requirements of §§ 9-703(f), 16-203, and 16-602, and Table 16-406: Required 23 Off-Street Parking.
