8 9	THE HEIGHT OF ANY NEW DEVELOPMENT OR OF ANY ADDITION OR ALTERATION TO AN EXISTING STRUCTURE MAY NOT EXCEED THE LESSER OF:
0	(1) 40 FEET; OR
1	(2) ANY LOWER MAXIMUM HEIGHT PERMITTED UNDER THE UNDERLYING ZONING.
