**AN ORDINANCE CONCERNING**

**Supplementary General Fund Operating Appropriation –  
Fire Department – \$7,000,000**

3 FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the  
4 amount of \$7,000,000 to the Fire Department – Service 602 (Fire Suppression and  
5 Emergency Rescue), to provide funding for additional operating expenses; and providing for  
6 a special effective date.

**Recitals**

13 The revenue appropriated by this Ordinance represents funds from Investment Earnings in  
14 excess of the revenue relied on by the Board of Estimates in determining the tax levy required to  
15 balance the budget for Fiscal Year 2019.

16 This additional revenue could not have been reasonably anticipated when the Ordinance of  
17 Estimates for Fiscal Year 2019 was formulated.

18 This appropriation is made necessary by a material change in circumstances since the  
19 Ordinance of Estimates for Fiscal Year 2019 was formulated or is for a new program that could  
20 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

21 On May 8, 2019, the Board of Estimates recommended this appropriation to the City Council.

**Council Bill 19-0395**

1       **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That the  
2 \$7,000,000 shall be made available to the Fire Department – Service 602 (Fire Suppression and  
3 Emergency Rescue) as a Supplementary General Fund Operating Appropriation for Fiscal Year  
4 2019, to provide funding for additional operating expenses. The source of revenue for this  
5 appropriation is funds from Investment Earnings in excess of the amount from this source that  
6 was relied on by the Board of Estimates in determining the tax levy required to balance the  
7 budget for Fiscal Year 2019.

8       **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it is  
9 enacted.
