18	Estimates for Fiscal Year 2019 was formulated.

24	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
25	\$10,000,000 shall be made available to the Baltimore City Information and Technology
26	Department – Service 805 (Enterprise IT Delivery Services) as a Supplementary General Fund
