The Department of Planning is in receipt of City Council Bill #19-0438, which is for the purpose of condemning and closing North Durham Street, extending from East Eager Street Northerly 433 feet, more or less, to the south side of East Chase Street; and a 16-foot alley, extending from the west side of North Durham Street 136.8 feet, more or less, to the west side of North Wolfe Street, as shown on Plat 341-A-45A in the Office of the Department of Transportation This bill is a companion bill to City Council Bill #19-0437 which is for the opening of North Durham Street.

The Department of Planning recommends approval of City Council Bill #19-0438 with the condition that upon the future sell of the street bed it would remain open as a private right-of-way for public use and not consolidated into any adjacent parcels.

The opening and closing of North Durham Street will help facilitate the eventual sale of the street bed of Durham Street to East Baltimore Development, Inc. (EBDI) and any future owners, as a portion of the street bed in currently improved with a portion of the existing Eager Park. To the west, new townhomes are currently under construction along this portion of Durham Street. While it is beneficial for the City to transfer ownership of this portion of the Durham Street, it is necessary that the bed remain a separate parcel from Eager Park and remain as a private right-of-way. The new homes are addressed to Durham Street and will need to retain street frontage, in this case as proposed private street frontage.
