## RE: City Council Bill #19-0451 Biennial Comprehensive Crime Reduction Plan

Dear Council President Scott and Members of the City Council:

The Baltimore Police Department (BPD) has reviewed Council Bill 19-0451. The bill requires that the Mayor's Office of Criminal Justice present to the City Council a biennial comprehensive crime reduction plan. The plan must be coordinated and developed in consultation with several city agencies, including the Baltimore City Police Department. The plan must analyze existing criminal justice data, assess policing practices, assess holistic efforts aimed at crime reduction, report on any public engagement measures taken or to be taken to assist in crime reduction, assess public attitudes and public education regarding criminal justice issues, and establish goals, priorities, and standards for the reduction of crime and the improvement of the administration of justice in Baltimore City.

The Baltimore Police Department fully recognizes that the path to successfully reducing violence involves more than law enforcement alone. In fact, in Commissioner Michael Harrison's Comprehensive Crime Reduction & Departmental Improvement Plan, he calls for a comprehensive multi-disciplinary violence reduction strategy that focuses on **Prevention, Intervention, Enforcement, Rehabilitation**, and **Re-Entry**. As such, BPD is committed to working collaboratively and cooperatively with our City's residents, businesses, advocacy groups, non-profit organizations, faith leaders, elected officials, as well as with other city, state, and federal agencies, to provide a multi-layer approach to solving underlying issues that lead to crime.

While the BPD defers to the Baltimore City Department of Law as to the legality of City Council Bill #19-0451, we would like to point out that § 29-10 (C)(2) of the bill which requires MOCJ to "assess policing practices" is in direct conflict with the mandates of the federal consent decree under which Baltimore City and the Baltimore Police Department are currently operating.
