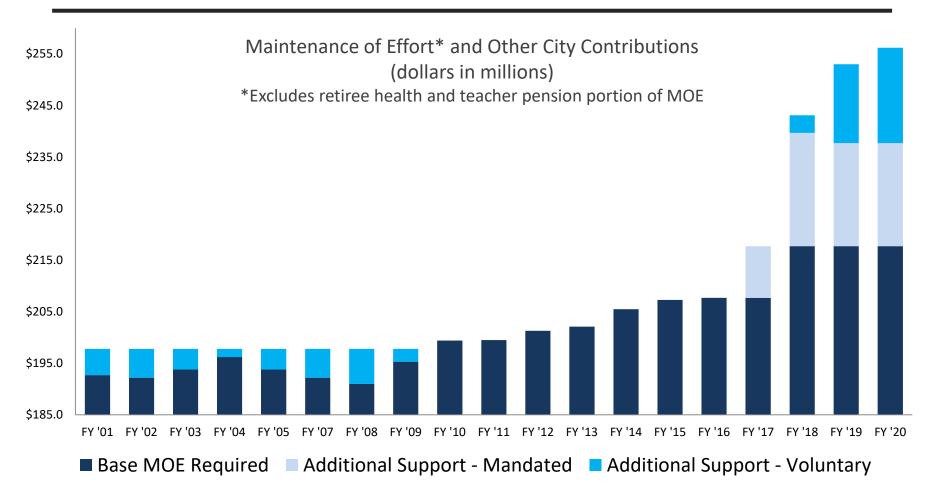

Operating Support



• In Fiscal 2020, the City is providing \$89.9 million more annually than was required by MOE funding formula.

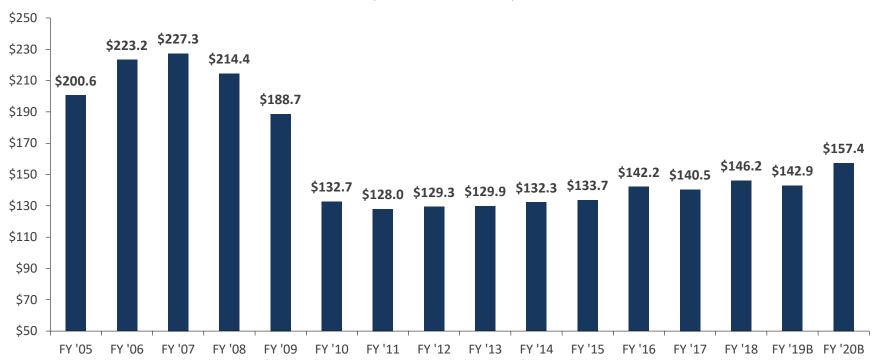
- Unlike operating support, State funding for school construction is not wealth equalized.
- State funds are not distributed based on wealth or the condition of schools.
- Wealthier jurisdictions are able to supplement construction funding with their higher tax base.
- Baltimore City does not have the means to supplement or keep pace with other jurisdictions.

State Highway User Revenues

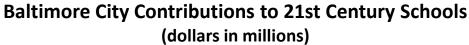

 Reduced State HUR funds since Fiscal 2007 has required funding transportation projects from the same pool as all other capital projects, including schools, putting pressure on the City's limited debt capacity.



21st Century Schools Contributions





*In FY 2016, the State deposited \$8 million of the City's required \$18 million contribution in the 21st Century Schools Fund; the remainder went directly to City Schools in the form of additional State Aid leveraged by the City.

- Intent was to share cost of program equally among three parties City, State, and City Schools
- The City made \$33 million of additional contributions through first five years, FY14-FY18.
- City Schools made no contributions in FY14, FY15, and FY16.
- The State made no contributions in FY14 and FY15.

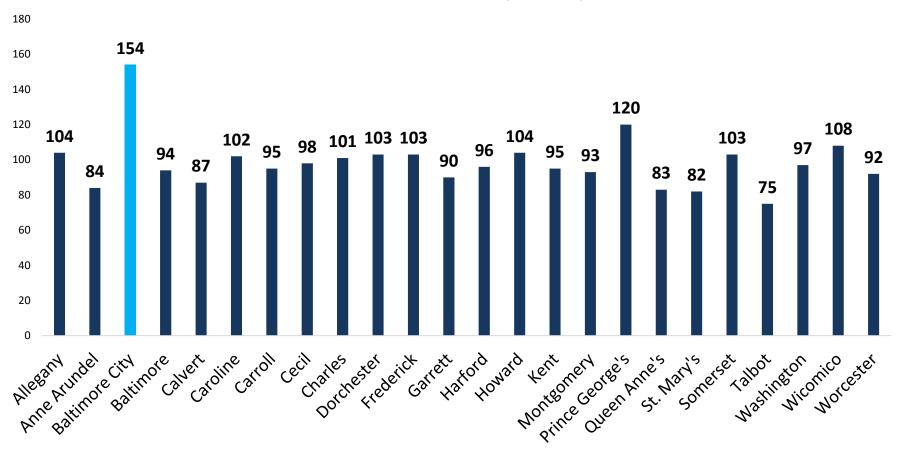

Combined Tax Effort (FY 2020)



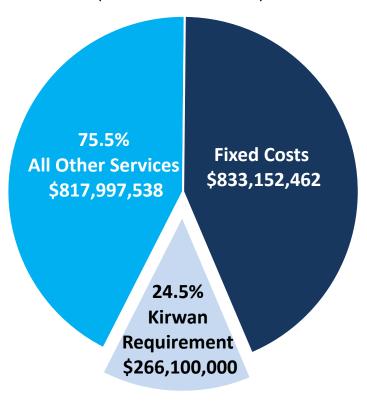
The City taxes its residents 54% more than the statewide average.
