Major Issues Discussed

- 1. Vice-Chair Sneed read the bill number, title, and purpose, and confirmed that the public notice requirements were met.
- 2. Jay Greene from the Department of Housing and Community Development (DHCD) explained the bill and noted that DHCD plans to work with a consultant to develop improvements to the inclusionary housing program over the next two years. He further noted that without the bill's enactment the program will expire on June 30, 2020.
- 3. Committee member questions:
 - a. What has DHCD done to study the effectiveness of the current program? DHCD has reviewed the program internally and intends to retain a consultant to provide further assistance.
 - b. Has DHCD prepared any reports based on its internal reviews of the program? DHCD has not generated any reports specific to its internal reviews at this point.
 - c. Why is it important to study the current law and potential changes? The law is very complex and DHCD thinks it needs expert assistance to make it more effective.
 - d. What is ineffective in the current law? DHCD would like the program to create many more affordable housing units. To date it has produced 36 affordable units in the 13 years since the current law was enacted. DHCD expects it to produce 6 additional units in the near future.
 - e. Has DHCD documented the current barriers to the program's effectiveness? DHCD is planning to use the two-year extension and the consultant to do that work.
 - f. What is the schedule for hiring the consultant? DHCD plans to post the RFP within the next week or so.
- 4. Representatives from the other reporting agencies confirmed the recommendations in their written reports.
- 5. Members of the public testified in support of the bill. Speakers noted that although the existing inclusionary housing program needs improvement it is important to prevent the law from expiring without a replacement.
- 6. Members of the Committee asked DHCD to provide additional information (see Further Study) before the Committee acts on the bill.
- 7. Vice-Chair Sneed recessed the hearing.
