Bev. § 12-902.1(c)(4) to allow the license holder holding a valid Class B-D-7 Beer, Wine, and Liquor License issued for use at 3607 Fleet Street, Baltimore, Maryland 21224 to apply to the Board of Liquor License Commissioners for Baltimore City to exchange their Class B-D-7 Beer, Wine, and Liquor License for a Class A-7 Beer, Wine, and Liquor License for use at 5601 Eastern Avenue k/a 5701A Fleet Street.

ANALYSIS

Current Law

Section 12-902.1(c) of the Alcoholic Beverages Article of the Maryland Code provides that the holder of a valid Class B-D-7 beer, wine, and liquor license issued on or before July 1, 2018, may apply to the Liquor Board to exchange the license for a Class A-7 license if the license holder first obtains approval by resolution of the Baltimore City Council.

The Class A-7 license authorizes the license holder to sell beer, wine, and liquor at retail at the place described in the license for off-premise consumption. The holder of a Class A-7 license may sell beer, wine, and liquor on Monday through Sunday from 9:00 a.m. to 10:00 p.m.

Resolution Summary

The resolution would give the Council's approval for the holder of the Class B-D-7 Beer, Wine, and Liquor License issued for use at 3607 Fleet Street to apply to the Board of Liquor License Commissioners for Baltimore City to exchange the license for a Class A-7 Beer, Wine, and Liquor License for use at 5601 Eastern Avenue k/a 5701A Fleet Street.
