## A COUNCIL RESOLUTION CONCERNING

Approval for the Exchange of a Class B-D-7 License to a 1 2 Class A-7 License – 1041 Greenmount Avenue 3 FOR the purpose of providing the required approval under Md. Code Ann., Alc. Bev. § 12-902.1(d)(1) to allow the license holder holding a valid Class B-D-7 Beer, Wine, and 4 Liquor License issued for 1041 Greenmount Avenue, Baltimore, Maryland 21202 to apply to 5 the Board of Liquor License Commissioners for Baltimore City to exchange their Class 6 7 B-D-7 Beer, Wine, and Liquor License for a Class A-7 Beer, Wine, and Liquor License. Recitals 8 9 Under Md. Code Ann., Alc. Bev. § 12-902.1(d)(1), a City Council resolution is required to allow a current holder of a valid Class B-D-7 Beer, Wine, and Liquor License issued on or before 10 July 1, 2018 to apply to the Board of Liquor License Commissioners for Baltimore City to 11 exchange their Class B-D-7 Beer, Wine, and Liquor License for a Class A-7 Beer, Wine, and 12 13 Liquor License. The Class A-7 License authorizes the license holder to sell Beer, Wine, and Liquor at retail at 14 the place described in the license for off-premise consumption. The holder of a Class A-7 15 License may sell Beer, Wine, and Liquor on Monday through Sunday from 10:00 a.m. to 16 17 midnight. The license holder wishes to apply to the Board to exchange the Class B-D-7 License issued 18 for use at 1041 Greenmount Avenue for a Class A-7 License. Accordingly, representatives of the 19 license holder have applied to the Baltimore City Council for approval of the exchange. 20 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That the City 21 Council authorizes, by and through this resolution, that the current holder of a Class B-D-7 Beer, 22 Wine, and Liquor License located at 1041 Greenmount Avenue, Baltimore, Maryland 21202, 23 may apply to the Board of Liquor License Commissioners for Baltimore City (the "Board") to 24 exchange its Class B-D-7 Beer, Wine, and Liquor License for a Class A-7 Beer, Wine, and 25 Liquor License and may be afforded all the privileges and responsibilities of that license class 26 and type under the Alcoholic Beverages Article for the State of Maryland. 27 AND BE IT FURTHER RESOLVED, That a copy of this Resolution be sent to the Executive 28 Secretary of the Board of Liquor License Commissioners for Baltimore City. 29
