AN ORDINANCE CONCERNING

2 FOR the purpose of allowing the appointment of co-chairs for the Commission on Sustainability.

8 SECTION 1. **BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE**, That the  
9 Laws of Baltimore City read as follows:

10 Baltimore City Code

11 Article 5. Finance, Property, and Procurement

12 Subtitle 34. Commission on Sustainability

13 § 34-2. Terms; Chair OR CO-CHAIRS.

14 . . .  
15 (b) *Commission Chair OR CO-CHAIRS.*

16 The Mayor shall appoint one member as Chair of the Commission OR MAY APPOINT TWO  
17 MEMBERS AS CO-CHAIRS OF THE COMMISSION.

18 SECTION 2. **AND BE IT FURTHER ORDAINED**, That the catchlines contained in this Ordinance  
19 are not law and may not be considered to have been enacted as a part of this or any prior  
20 Ordinance.

21 SECTION 3. **AND BE IT FURTHER ORDAINED**, That this Ordinance takes effect on the 30<sup>th</sup> day  
22 after the date it is enacted.


