7 8 9 10	(1) THE BALTIMORE CITY FIRE DEPARTMENT SHALL NOTIFY THE BALTIMORE CITY COUNCIL THAT THE FIRE DEPARTMENT HAS BEGAN THE HIRING PROCESS FOR ENTRY- LEVEL FIRE SUPPRESSION OR EMERGENCY MEDICAL SERVICES POSITIONS OR HAS MOVED INTO A NEW PHASE OF THE HIRING PROCESS FOR THOSE POSITIONS.

24 25 26	SECTION 2. AND BE IT FURTHER ORDAINED , That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.
27 28 29 30	SECTION 3. AND BE IT FURTHER ORDAINED , That the first reports under this section shall be due on or before January 31, 2021, and shall include information from each of the previous 5 calendar years; thereafter, each report need only include information from the previous calendar year.
31 32	SECTION 4. AND BE IT FURTHER ORDAINED , That this Ordinance takes effect on the 30 th day after the date it is enacted.
