16	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the
17	Department of Transportation shall proceed to condemn and close a 13-foot alley, extending
18	from East Biddle Street Northerly 80 feet, to a 20-foot alley; and a 20-foot alley, extending from
19	North Washington Street Easterly 241.5 feet, more or less, laid out in the rear of the properties
20	known as nos. 2000 through 2030 East Biddle Street, and more particularly described as follows:
21	Beginning for Parcel 1 at the point formed by the intersection of the east side of a
22	13-foot alley and the north side of East Biddle Street 66 feet wide, the point of
23	beginning being distant 194 feet measured along the north side of East Biddle
24	Street from the intersection of North Chester Street 60 feet wide, and the north
25	side of East Biddle Street; thence binding on the north side of East Biddle Street
26	Westerly 13 feet to the west side of the 13-foot alley; thence binding on the west
27	side of 13-foot alley Northerly 80 feet to intersect the south side of a 20-foot alley;

AND BE IT FURTHER ORDAINED, That the proceedings for the condemnation and 23 closing of the 13-foot alley and the 20-foot alley and the rights of all interested parties shall be 24 regulated by and in accordance with all applicable provisions of state and local law and with all 25 applicable rules and regulations adopted by the Director of Transportation and filed with the Department of Legislative Reference. 26 27 SECTION 3. AND BE IT FURTHER ORDAINED, That after the closing under this Ordinance, all subsurface structures and appurtenances now owned by the Mayor and City Council of Baltimore 28 29 continue to be the property of the Mayor and City Council, in fee simple, until their use has been abandoned by the Mayor and City Council. If any person wants to remove, alter, or interfere with 30 them, that person must first obtain permission from the Mayor and City Council and, in the 31 application for this permission, must agree to pay all costs and expenses, of every kind, arising 32 33 out of the removal, alteration, or interference. 34 SECTION 4. AND BE IT FURTHER ORDAINED, That no building or structure of any kind (including but not limited to railroad tracks) may be constructed or erected in or on any part of 35 36 the street closed under this Ordinance until all subsurface structures and appurtenances owned by the Mayor and City Council of Baltimore have been abandoned by the Mayor and City Council 37 or, at the expense of the person seeking to erect the building or structure, have been removed and 38 39 relaid in accordance with the specifications and under the direction of the Director of Transportation of Baltimore City. 40 SECTION 5. AND BE IT FURTHER ORDAINED, That after the closing under this Ordinance, all

AND BE IT FURTHER ORDAINED, That at all times after the closing under this Ordinance, the Mayor and City Council of Baltimore, acting by or through its authorized representatives, shall have access to the subject property and to all subsurface structures and appurtenances used by the Mayor and City Council, for the purpose of inspecting, maintaining, repairing, altering, relocating, or replacing any of them, without need to obtain permission from or pay compensation to the owner of the property.
9	SECTION 7. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
