Major Issues Discussed

- 1. The representative from the Mayor's Office gave opening remarks. Some highlights from his conversation were:
 - Baltimore City's Director of Public Work is a unique position when compared to other jurisdictions.
 - We believe the new salary range will be competitive
 - Other jurisdictions are not like the city's DPW; there are key differences! (A Study was shown displaying salary data for some of the DPW Directors across the U.S.A. The representative from the <u>Department of Human Resources</u> explained the Study see below **) A copy of the Study is on file.
- 2. Several city agency representatives testified:
 - Department of Public Works (DPW)
 - Talked about their agency report and about some of DPW's organizational structure and responsibilities. Some topics mentioned were:
 - o There are over 2,700 employees within the DPW; many different positions
 - o Talked about the water/wastewater treatment plans must operate 24 hours a day
 - o Talked about the importance of the Director's position, about duties and responsibilities associated with the position
 - o Processes within the Department can be very challenging
 - Law Department
 - Talked about their agency report and about the law pertaining to recruiting and/or increasing the salary for the Director of DPW position
 - Department of Human Resources
 - Talked about their agency report and believes the new salary is competitive and will attract good candidates
 - ** Explained how the Study was conducted and talked about some of the differences in responsibilities for DPW Director positions in other jurisdictions when compared to the responsibilities associated with the City's Director of DPW position
 - Talked about how the comparisons were conducted
 - Director of DPW for City is quite unique!
 - City's position has more responsibilities when compared to other jurisdictions
 - In other jurisdictions all divisions are not under the DPW Director
 - All divisions for the City's Department of Public Works are under the DPW Director
 - Discussed "comparisons of salary versus comparisons of responsibilities"
 - Department of Finance (BBMR)
 - Talked about briefly about their agency report

- 3. The committee/councilmembers asked questions, made comments and/or stated concerns. Some highlights for same were:
 - Questions and Comments
 - Can you explain the city's DPW responsibilities and its connection to Baltimore and Howard counties?
 - Do you have a candidate in mind yet? Answer: No
 - The DPW receives the highest budget in the City; so why doesn't the Director get paid the most salary compared to other departments? The challenges are great within the Department!
 - Concern: Water pricing and rate increases (We need someone who can think outside the box)
 - Comment: I don't think the \$244,000 is quite enough!
 - Comment: We need someone with a broad expertise
 - Comments: Feel the need for increase is real and needed; glad to see we are moving in this direction. There are a lot of duties and responsibilities within the Department
 - Comment: Hope the candidate chosen will get the freedom to lead the Department
 - Comment: Hope the candidate chosen will have the power to empower those below him/her (the Deputies)
 - Comment/Concern: Just want to make sure the city is competitive when hiring the Director
 - Where is the funding coming from for the increase? Answer: Finance have identified a line item that is being underserved; Service 670
 - Request(s)
