Major Issues Discussed

- 1. Councilwoman Middleton opened the meeting, introduced committee members and City representatives, and read the bill title and purpose into the record. She provided general comments about her sponsorship of the bill.
- 2. The committee asked questions and discussed amendments. Discussion centered on how residential security deposit insurance applies to a tenant and landlord; how State law regulates surety bonds; whether security deposits can be collected as additional rent; payout of claims and the tenant's right to appeal claims; and prior inspection and documentation of the condition of leased units.
- 3. The committee voted to approve certain amendments.
- 4. The committee approved the bill favorable as amended.
