# AN ORDINANCE CONCERNING

### Rezoning – 2426 Pennsylvania Avenue

- FOR the purpose of changing the zoning for the property known as 2426 Pennsylvania Avenue
  (Block 0294, Lot 014), as outlined in red on the accompanying plat, from the OR-1/R-MU
  Zoning District to the C-1-E Zoning District.

### 11 SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That

- 12 Sheet 44 of the Zoning District Map is amended by changing from the OR-1/R-MU Zoning
- 13 District to the C-1-E Zoning District the property known as 2426 Pennsylvania Avenue (Block
- 14 0294, Lot 014), as outlined in red on the plat accompanying this Ordinance.
- 15 SECTION 2. AND BE IT FURTHER ORDAINED, That as evidence of the authenticity of the accompanying plat and in order to give notice to the agencies that administer the City Zoning 16 Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council 17 18 shall sign the plat; (ii) when the Mayor approves this Ordinance, the Mayor shall sign the plat; and (iii) the Director of Finance then shall transmit a copy of this Ordinance and the plat to the 19 Board of Municipal and Zoning Appeals, the Planning Commission, the Commissioner of 20 Housing and Community Development, the Supervisor of Assessments for Baltimore City, and 21 the Zoning Administrator. 22
- SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30<sup>th</sup> day
  after the date it is enacted.
