Major Issues Discussed

- 1. Chairwoman Middleton called the hearing to order, introduced the Committee members and staff in attendance, and read the bill number, title, and purpose.
- 2. Jamaal Simpson, on behalf of Councilman Glover, discussed the importance of and need for the bill.
- 3. Representatives for City agencies summarized their agencies' written reports.
- 4. Hilary Ruley explained the Law Department's concerns with the bill and responded to Committee member questions.
- 5. Bill Wells noted that the Housing Authority had not submitted a written report because they understand there will likely be amendments. He explained that the bill could impact Housing Authority operations and asked that the Housing Authority be exempted from the bill's requirements if it is passed.
- 6. Sabrina Tapp-Harper read a letter from the Attorney General's Office regarding the bill and noted that the Sheriff's Office defers to the Law Department.
- 7. Aaron Degraffenreidt and Nikki Thompson discussed potential amendments that the President's Office is developing to address the Law Department's concerns.
- 8. Supporters of the bill testified that avoiding evictions helps to protect families from homelessness and reduce the spread of COVID-19, and argued that the bill does not conflict with state law.
- 9. Opponents of the bill testified that it would conflict with lease agreements and state law, and that 'just cause' court proceedings could adversely affect tenants.
- 10. Chairwoman Middleton noted that the Committee would schedule a work session on the bill at a later date and recessed the hearing.
