Major Issues Discussed

- 3. After each agency head concluded his/her presentation, the committee/council members asked questions, stated concerns, asked for clarification, and etc. Some highlights of same were:

Baltimore Development Corporation - BDC

- o Economic Recovery
 - BDC was asked to talk about some of their strategies used for economic recovery
 - Are there any indicators for job figures?
- Design for Districting Program
 - Is any data available regarding job retention, job creation, and etc.?
 - Can any of the American Rescue funds be used for the program?
- o Pimlico Area Redevelopment
 - The area is going through massive redevelopment but there are still many challenged neighborhoods there is of concern
 - Talk about BDC's involvement in this redevelopment; to include the challenged neighborhoods
- o Family Dollar/Dollar General Businesses
 - There are some disrespectful businesses in our neighborhoods; talk about this issue.
 - A Dollar General is coming to Greenmount Avenue. No public notice was given and I would like to be involved. What is BDC's role in bringing businesses into the community and notifying the community?
- o Made in Baltimore
 - Can you talk about this initiative and how it is going?

o Federal Funds

 Request: Provide a list for organizations who received recovery funds; to include the recipients and the amount given.

Visit Baltimore/Convention Center

- City Neighborhoods versus Focusing on Tourism
 - We need to focus more on neighborhoods
 - We want people to say this is a great place to live!
 - How can we get people to know Baltimore City is a great place to live!

o Tourism/Conferences

- Talk about some of the upcoming conferences to be held in Baltimore
- Comment: Hope homeless people are not arbitrarily kicked out of the hotels when the economy picks up.

Mayor's Office of Minority and Women Owned Small Business Development

- o Training
 - Do you have any outcomes for successful businesses that received training from your office?

 - What is the Department doing to ensure we do not have food deserts in the city?
 - Once the pandemic is over, are we going to have better access to food? What is the strategy?
 - Food deserts need to be addressed is of concern
 - The evaluation matrix for needing a market within communities is of concern
 - What kind of matrices are you using?
 - You may need to use other indicators; key matrices are needed

Housing Code Enforcement

Illegal Dumping

- Since agents can't be out at night, can they monitor the cameras at night?
- Illegal dumping is a major concern across all districts; legislation was recently passed to increase fines for same
- What are some of the improvements and efficiencies you are looking at for illegal dumping?
- · Your department definitely need more funding for this issue

Citations

- Does code enforcement always come out on day eleven (11) to re-inspect?

Vacant Property

- Concern: making sure every available measure is taken, implemented and/or followed-up; no property falling by the waste side!

Weatherization Program

- How does this program assist landlords?
- Is there a breakdown for how much weatherization is provided to tenants versus to the landlords? Request: Please research and provide data

Community Block Grants

- How many grants were disbursed so far? Request: Please research and provide data
- CDBG Block Grants the delay of awarding the grants; talk about this.
- Request: Provide a list of everyone who received CDBG funding during the past five years, by district

o Homeownership

From renting to homeownership – more funding is needed

Mowing Services

• What is the possibility of placing this service in a "one stop shop?" We need to have a conversation about this!

Light Program

There is a massive waiting list for the light program; can you talk about the waiting list?

o Pandemic

What strategies are in place as the city emerges from the pandemic?

o Family Dollar Businesses

- There are some disrespectful businesses in our neighborhoods; is unclean outside of business
- Is there an update on these establishments?

o Permit Office

• Concern: Sometimes plans are wrong but are still approved; those plans should have never been approved and causes the work done to be redone! What are you doing to correct this?

Affordable Housing
