Major Issues Discussed

- 1. Councilmember Middleton opened the meeting, introduced committee members and read the bill into the record.
- 2. Councilmember Costello commented about the purpose of the bill.
- 3. Tamara Woods presented the Planning Commission's report which supports the bill. She emphasized that the bill is a result of actions taken in 2016 which created the Port Covington Master Plan. Zoning designated by the Transform Baltimore comprehensive rezoning process supports the goals of the Port Covington Master Plan. One recommendation of the Master Plan is to repeal the planned unit development for the site so that future development can proceed. Development of the site is compatible with goals of the Comprehensive Master Plan for Baltimore City, specifically to retain and attract businesses in all growth sectors.
- 4. Agency representatives provided reports for their respective agencies.
- 5. The committee opened the hearing for public testimony.
- 6. Jon Laria testified on behalf of the applicant in support of the bill. He provided background information about the property and proposed use.
- 7. Adam Genn testified in support of the bill.
- 8. The committee approved findings of facts for the bill
- 9. The committee approved a motion to recommend the bill favorably.
- 10. The hearing was adjourned.
