# **Major Issues Discussed**

- 1. Councilmember Middleton read the bill into the record and introduced councilmembers in attendance.
- 2. Councilmember Porter commented about the purpose of the bill stressing that the Wilkens Avenue bridge needed to be replaced. She also stated that the Gwynns Falls Community Association supports the bill.
- 3. Liam Davis provided information about the age of the bridge and why it needs to be replaced as part of the City's Capital Improvement Program. He also explained that the gas line on the bridge will be replaced as well as an associated regulator. The regulator will be relocated nearby. He explained the urgency of the project which is federally-funded and guided by certain advertising guidelines which should be met by August 2022. There was also discussion about coordination of the construction project to prevent certain detours and traffic problems.
- 4. Victor Tervala provided the Law Department's report which approved the bill for form and legal sufficiency.
- 5. Agency representatives provided reports for their respective agencies.
- 6. The committee opened the hearing for public testimony.
- 7. The committee answered community questions about location of the project. The project is within a few feet of Wilkens Avenue bridge and is not along Gwynns Falls Parkway.
- 8. The committee approved a motion to recommend the bill as favorable.
- 9. The hearing was adjourned.
