Budget Briefing – Baltimore City Public Schools CLOSEOUT – FISCAL YEAR 2021

Purpose:

For the purpose of calling on regular budget oversight hearings for Baltimore City Public Schools to improve transparency and accountability in the allocation of over a billion dollars in public funding for the vital task of educating Baltimore's children.

Current Law

Baltimore City Code – Article 1, Subtitle 1-City Council, Sections 1-5 and 1-6

§ 1-5. Agencies to provide budget status reports.

(a) *Reports required*.

On or before November 1, February 1, May 1, and August 1 each year, the City agencies <u>so requested</u> shall file quarterly budget status reports with the Budget and Appropriations Committee of the City Council. (b) *Contents*.

Each report shall contain the information required by the Committee and be in the format requested.

(c) Public hearing.


The Committee may hold a public hearing for those agencies not reporting or those showing a projected deficit for the fiscal year.

(d) "City agency" defined

The words "City agencies" include the City trustees and all City sponsored and financed nonprofit corporations. (City Code, 1976/83, art. 1, §5.) (Ord. 72-211; Ord. 77-333; Ord. 81-568; Ord. 82-753.)

§ 1-6. Agencies to provide legislative information.

It shall be the duty of the head of every City department or bureau established by the Baltimore City Charter or by ordinance to provide all technical materials, plats, drawings, and information that are requested by any member or the President of the City Council for the purpose of introducing legislation into the Council. *(City Code, 1976/83, art. 1, §6.) (Ord. 76-080.)*



Background

<u>On October 15, 2020</u> representatives from the Baltimore City Public School System gave a PowerPoint Presentation to discuss <u>Fiscal Year 2020 Closeout</u> which <u>ended June 30, 2020</u>. *A copy of the Presentation for Fiscal Year 2020 Closeout is attached*. Some highlighted topics from the Presentation and/or testimony were:

- Discussed fiscal year 2020 closeout
- Talked about some of the major investments
- Talked about the installation of air filters in schools
- Gave an update on "virtual learning"
- Discussed:
 - a. CARES Act Reimbursements
 - b. FEMA Reimbursements
 - c. Last Quarter was a COVID environment (COVID Heavy)
 - d. PPE equipment/distribution
 - e. Importance of keeping the children and buildings safe
 - f. Implementation of hiring freeze
 - g. Transportation
 - No more transportation used to transport students since the COVID lockdown
 - Re-negotiated the transportation contracts
- Comments:
 - a. For the third (3rd) time in six (6) years the teacher of the year is from Baltimore city; to include this year. It is an honor!
 - b. Fiscal Year 2022 will be an extraordinary challenge; it is right around the corner!
 - c. Concerned about Kirwan funding
- Audits:
 - a. For eleven (11) years the BCPSS external audits (financial statements) have been clean!

<u>On October 26, 2021</u> representatives from the Baltimore City Public School System will give a PowerPoint Presentation to discuss <u>Fiscal Year 2021 Closeout</u> which <u>ended June 30, 2021</u>.

And representatives from BCPS is also scheduled to come before the committee on <u>Tuesday</u>, <u>November 9, 2021</u> to discuss their <u>first quarter projection for Fiscal Year 2022</u>, for the period July 1, 2021 through September 30, 2021.

Introduction

In early August, we estimated initial additional COVID costs of approximately \$131 million

Federal, State and local additional revenues available for these costs total approximately \$77 million; after repurposing FY20 and FY21 funds wherever possible, and estimating an application of \$16 million from FY20 close-out funds, a remaining FY21 gap of approximately \$21 million was estimated.

The approved FY21 Budget contained no COVID-related costs

Introduction, Continued

After closing FY20, City Schools was able to apply \$26 million toward COVID costs, bringing the remaining estimated gap down to approximately \$11 million

There are certain items and conditions that City Schools must have in place to ensure safe and successful schools for our children. These items include, but are not limited to: **Newly Pledged Amounts, Not in Original FY21 Budget:**

•Clean, safe buildings for children and staff Ample supplies of PPE •On-going connectivity, devices and support to address the digital divide

→\$9MM – Building Safety, Enhancements, Increased Cleaning →\$8MM – PPE, Barriers, Safety Signage & Reminders

→ \$9MM – Connectivity, Technology & Support

Closing the Gap

From the beginning (March, FY20) we have endeavored to save funds wherever possible

- Spending freeze
- Hiring freeze
- Reduced 3rd party contractor costs
- **Re-negotiated transportation contracts**

In FY21, we have continued to take multiple, prudent and proactive steps to adapt to our new reality and ensure financial stability and viability for FY21 and beyond Examples of some recent actions:

- projected savings in Temps Category
- projected savings by repurposing grant funds to other allowable uses
- projected savings from hiring freeze

Preparing for the Future and Closing the Next Gap(s)

We are meeting the most immediate challenges

FY22 is shaping up to be very challenging for multiple, compounding reasons

As we completed the FY20 close out process, we took into consideration all of these longer-term needs of the system and the flexibility required to meet the needs of our students, staff, and community in FY21 and beyond
