AN ORDINANCE CONCERNING

City Property – Grant of Easements 1 2 FOR the purpose of authorizing the Mayor and City Council of Baltimore to grant 2 Perpetual Easements to the Maryland State Highway Administration for the maintenance of 2 storm 3 4 water drainage inlets along Dulaney Valley Road, through the property of the Loch Raven 5 Reservoir, in Baltimore County, Maryland, as shown on Plat 61536 filed in the State 6 Highway Administration State Roads Commission; and providing for a special effective date. 7 By authority of 8 Article V - Comptroller 9 Section 5(b) 10 **Baltimore City Charter** (1996 Edition) 11 SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the 12 13 Comptroller of Baltimore City is hereby authorized to grant 2 Perpetual Easements, to the 14 Maryland State Highway Administration for the maintenance of 2 storm water drainage inlets along Dulaney Valley Road, through the property of the Loch Raven Reservoir, in Baltimore 15 County, Maryland, and more particularly described as follows: 16 17 Beginning for the same at a point on the western side of MD Route 146 (Dulaney 18 Valley Road) 60 feet wide, the point of beginning being offset 30.53 feet to the left of station 130 + 94.89 feet of the baseline of right of way and survey as shown 19 20 on State of Maryland Acquisition Plat 61536 running thence binding the 4 following courses and distances; 21
