## > Police Department

- Can you provide the committee with the total number of police officers, sergeants, and lieutenants that are assigned to uniform patrol functions in all nine districts?
  - Please see the attached document entitled Patrol Staffing Totals
- Can you send the committee the District Staffing Charts that are submitted to the Chief of Patrol's Office from all nine districts that you've collected for the month of September? We have several different reports that are submitted to the COP, can you please provide me with an example of what you are looking for please?
- Can you provide the committee with the police departments plan on how they will conduct the process of redistricting patrol districts?
  As you are aware, the law requires that within 1 year from the issuance of the decennial census population and housing data by the US Census Bureau, the Commissioner must develop a plan for the adjustment of the geographic boundaries and composition of each district and the reallocation of the resources and personnel of the department among the districts. The Census Bureau released the shape files in August.

The law provides that we must consider the following factors in the development of the plan:

- 1-Decennial census population and housing data of the United States Census Bureau;
- 2-District call volume trends:
- 3-District response times;
- 4-Any other information deemed necessary by the Commissioner. The Commissioner has decided to consider the following additional factors:
  - Neighborhood boundaries should be considered so as to keep neighborhoods in tact within police districts, where possible.
  - The current number of police districts will be maintained
  - Once the district boundaries are finalized, staffing allocations will be redistributed to accommodate the new work load for each district.

The Commissioner will hire a professional consultant who has demonstrated considerable expertise in the development of such plans and will seek input from community residents and elected officials.

 Sexual assault data, clearance rates for all sexual assaults & forcible rape


As of 10/16/21 the clearance rate for rape is 10.7% 2021 YTD. Based on case status and closed date from Lotus Notes Sex Offense database, the clearance rate for all documented sex offense cases is approximately 19.2% with 53 closed cases and 276 total cases 2021 YTD.

Also please note that for the month of January 2021 the Sex Offense Unit had 26 Cases and 9 Clearances for an overall 35% clearance rate in January. We believe that the glitch we had experienced in the RMS conversion led to an incorrect reporting of a 0% clearance rate at the September oversight hearing.
