Dear Honorable President Mosby and Members of the City Council:

I am pleased to inform your Honorable Body that I have signed into law this day the following bills:

22-0204 - Vacant Structures - 3-1-1 Complaint Fines

For the purpose of establishing a fee structure for repeated substantiated 3-1-1 service requests; providing for a special effective date; and generally relating to fining the owner of a vacant structure for repeated service requests.

22-0214 - Franchise - Underground Snow Melt System

For the purpose of granting a franchise to the Johns Hopkins Hospital to construct, use, and maintain an underground snow melt system, subject to certain terms, conditions, and reservations; and providing for a special effective date.

22-0289 - Zoning - Conditional Use Conversion of a Single-Family Dwelling Unit to 3 Dwelling Units in the R-8 Zoning District - 867 Hollins Street

For the purpose of permitting, subject to certain conditions, the conversion of a single-family dwelling into 3 dwelling units in the R-8 Zoning District on the property known as 867 Hollins Street (Block 0237, Lot 039), as outlined in red on the accompanying plat.

22-0300 - Waterfront Management District and Waterfront Management Authority - Renewal Through April 23, 2027

For the purpose of renewing and continuing the Waterfront Management District and Waterfront Management Authority; providing for a special effective date; and generally relating to the activities and authority of the Waterfront Management District and Waterfront Management Authority.

22-0304 - Supplementary General Fund Operating Appropriation - Health Department - \$310,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$310,000.00 to the Health Department - Service 723 (Advocacy for Seniors), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0305 - Supplementary General Fund Operating Appropriation - Health Department - \$1,500,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$1,500,000.00 to the Health Department - Service 303 (Clinical Services), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0306 - Supplementary General Fund Operating Appropriation - Health Department - \$32,000,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$32,000,000.00 to the Health Department - Service 315 (Emergency Services - Health), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0307 - Supplementary General Fund Operating Appropriation - Health Department - \$35,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$35,000.00 to the Health Department - Service 310 (School Health Services), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0308 - Supplementary General Fund Operating Appropriation - Department of General Services - \$750,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$750,000.00 to the Department of General Services - Service 726 (Administration - General Services), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0309 - Supplementary General Fund Operating Appropriation - Department of General Services - \$675,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$675,000.00 to the Department of General Services - Service 734 (Capital Projects Division), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0310 - Supplementary General Fund Operating Appropriation - Department of General Services - \$8,400,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$8,400,000.00 to the Department of General Services - Service 731 (Facilities Management), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0311 - Supplementary General Fund Operating Appropriation - Department of Finance - \$1,900,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$1,900,000.00 to the Department of Finance - Service 704 (Accounting), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0312 - Supplementary General Fund Operating Appropriation - Mayoralty: Convention Center Hotel - \$5,375,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$5,375,000.00 to the Mayoralty: Convention Center Hotel - Service 535 (Convention Center Hotel), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0313 - Supplementary General Fund Operating Appropriation - Mayoralty: Miscellaneous General Expenses - \$22,400,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$22,400,000.00 to the Mayoralty: Miscellaneous General Expenses - Service 122 (Miscellaneous General Expenses), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0314 - Supplementary General Fund Operating Appropriation - Department of Planning - \$485,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$485,000.00 to the Department of Planning - Service 768 (Administration - Planning), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0315 - Supplementary General Fund Operating Appropriation - Department of Planning - \$13,520,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$13,520,000.00 to the Department of Planning - Service 765 (Planning for a Sustainable Baltimore), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0316 - Supplementary General Fund Operating Appropriation - Department of Public Works - \$2,725,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$2,725,000.00 to the Department of Public Works - Service 676 (Administration - DPW), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0317 - Supplementary General Fund Operating Appropriation - Department of Transportation - \$1,575,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$1,575,000.00 to the Department of Transportation - Service 688 (Snow and Ice Removal), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0318 - Supplementary General Fund Operating Appropriation - Department of Transportation - \$275,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$275,000.00 to the Department of Transportation - Service 500 (Street Lighting), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

22-0319 - Supplementary General Fund Operating Appropriation - Department of Transportation - \$2,575,000

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$2,575,000.00 to the Department of Transportation - Service 697 (Traffic Safety), to provide funding for Fiscal Year 2022 expenses; and providing for a special effective date.

23-0328 - Supplementary General Fund Operating Appropriation - Office of Equity and Civil Rights - \$2,388,311

For the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$2,388,311.00 to the Office of Equity and Civil Rights - Service 849 (Police Accountability Board), to provide funding to secure the necessary staffing, equipment, technology, and training resources to support the Baltimore City Police Accountability Board and Administrative Charging Committee and to implement related police accountability; and providing for a special effective date.

INTRODUCTION AND READ FIRST TIME

The President laid before the City Council the following bills and Resolutions of the Mayor and City Council for first reading:

Bill No. 23-0374 - By Councilmember Ramos and City Council President (Administration - Department of Housing and Community Development)

An Ordinance authorizing the Mayor and City Council of Baltimore to sell, at either public or private sale, all its interest in certain property that is located at 707 East 34th Street (Block 4053, Lot 076) and is no longer needed for public use; and providing for a special effective date.

The bill was read the first time and referred to the Ways and Means Committee.

Bill No. 23-0375 - By Councilmember Ramos

An Ordinance changing the name of REACH! Partnership School Field, located at 2555 Harford Road, Baltimore, MD 21218, to Senator Robert L. Dalton Stadium.

The bill was read the first time and referred to the Education, Workforce and Youth Committee.

Bill No. 23-0376 - Accountability and Transparency in City Grantmaking

An Ordinance defining certain terms; requiring certain recipients of City grants to submit certain documentation; requiring the Board of Estimates to post certain information on its website; requiring certain employees and board members of certain organizations to file a certain financial disclosure; providing for a special effective date; and generally related to accountability and transparency in City grantmaking.

The bill was read the first time and referred to the Rules and Legislative Oversight Committee.

Bill No. 23-0377 - Surveillance Technology - Procurement

An Ordinance creating the Community Advisory Commission on Surveillance; providing for the membership and duties of the Commission; requiring City Council approval for the purchase of certain equipment; requiring City agencies to submit certain reports; defining certain terms; and generally relating to the City's procurement of surveillance technology.

The bill was read the first time and referred to the Public Safety and Government Operations Committee.

Bill No. 23-0378 - Unlawful Practices - Discrimination Based on Characteristics or Status

An Ordinance extending certain protections against discrimination to an individual regardless of the individual's HIV or AIDS status, other characteristics or status, or association with individuals with a particular characteristic or status; prohibiting the willful use of the incorrect name or pronouns of an individual under certain circumstances; requiring a certain notice be posted in certain facilities; and generally relating to discrimination based on an individual's protected status.

The bill was read the first time and referred to the Public Safety and Government Operations Committee.

Bill No. 23-0379 - Facial Recognition Technology

An Ordinance regulating the use of facial recognition technology; requiring possessors of data recovered from facial recognition technology to develop a certain policy regarding retention and destruction of data; establishing certain penalties; defining certain terms; and generally relating to the use of facial recognition technology.

The bill was read the first time and referred to the Health, Environment, and Technology Committee.

Bill No. 23-0380 - Charter Amendment - Community Reinvestment and Reparations Fund

An Ordinance establishing a continuing, non-lapsing Community Reinvestment and Reparations Fund, to be used exclusively to support the work of the Community Reinvestment and Reparations Commission; authorizing the Mayor and City Council, by ordinance, to provide for the oversight, governance, and administration of this Fund; and submitting this amendment to the qualified voters of the City for adoption or rejection.

The bill was read the first time and referred to the Economic and Community Development Committee

Bill No. 23-0168R - Informational Hearing - State of Maternal Health in Baltimore City

A Resolution inviting representatives from the Baltimore City Health Department, Baltimore City Fire Department, Baltimore Police Department, and other interested parties to appear before the City Council to discuss maternal health in Baltimore City, including the current state of maternal health and any inequities that currently exist in maternal health delivery and outcomes.

The bill was read the first time and referred to the Health, Environment, and Technology Committee.

Bill No. 23-0169R - By Councilmember Cohen

Introduced (Read and adopted)

Welcoming the Golden Rule Peace Ship to Baltimore

FOR the purpose of welcoming the Golden Rule Peace Ship (the Golden Rule) to Baltimore City; and encouraging Baltimoreans to visit the ship and learn about its history.

Recitals

WHEREAS, on May 1st, 1958, 4 nuclear weapons abolitionists sailed a 39-foot ketch, the Golden Rule, towards the Marshall Islands to protest nuclear bomb tests that were producing globally detectable radioactive fallout, an action that resulted in their arrest, captured the public's attention, and led to the 1963 ratification of the Limited Nuclear Test Ban Treaty by the United States, the Soviet Union, and the United Kingdom.

WHEREAS, in 2010, in the wake of the Golden Rule's second sinking, Veterans for Peace, wooden boat enthusiasts, and other volunteers salvaged and restored the Golden Rule.

WHEREAS, the Golden Rule is now undertaking a 15-month educational "Great Loop" tour, sailing down the Mississippi River and other rivers, around the Gulf of Mexico, down to Key West and Cuba, up the East Coast, and through the Great Lakes to Chicago. The Golden Rule will visit over 100 ports of call, including Baltimore.

WHEREAS, the Golden Rule will dock in Baltimore City between April 27th, 2023 and May 3rd, 2023.

WHEREAS, Marylanders in general, and Baltimoreans in particular, have repeatedly expressed their strong opposition to nuclear weapons in many ways over the years, including:

- (1) the declaration of Nuclear Free Zones in Baltimore in 1992;
- (2) Mayor Dixon's commitment to work towards a ban on nuclear weapons with Mayors for Peace in 2008;
- (3) the passage of Council Bill 18-0096R, Request for Federal Action Move Back from the Brink and Toward Nuclear Disarmament in 2018; and

(4) Baltimore-based organization Prevent Nuclear War Maryland's ongoing advocacy for verifiable global nuclear disarmament.

WHEREAS, the Golden Rule and crew will be welcoming the public to free tours of the historic boat at Pier 5 and making themselves available for public educational talks at various venues to celebrate the 65th anniversary of the 1958 arrests and the launch of citizen action to prevent nuclear war.

Now, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, that the City Council welcomes the Golden Rule Peace Ship to Baltimore City waters and encourages Baltimoreans to visit the vessel, to learn about its history, and to extend every courtesy to the boat and its crew.

AND BE IT FURTHER RESOLVED, That a copy of this Resolution be sent to the Mayor and the Mayor's Legislative Liaison to the City Council.

- (1) EACH MEMBER OF THE CITY COUNCIL AND THE CITY COUNCIL PRESIDENT SHALL PROPOSE 1 CANDIDATE TO THE MAYOR FOR THE MAYOR'S CONSIDERATION FOR APPOINTMENT TO THE COMMISSION.
- (2) THE MAYOR SHALL CONSIDER THE CANDIDATES PROPOSED BY THE CITY COUNCIL FOR APPOINTMENT TO THE BOARD AND MAY NOMINATE THE CANDIDATES AT THE MAYOR'S DISCRETION IN ACCORDANCE WITH CITY CHARTER ARTICLE IV, § 6.
- (3) IF THE MAYOR REJECTS A CANDIDATE PROPOSED BY THE CITY COUNCIL, THE MAYOR MUST PROVIDE A WRITTEN RESPONSE TO THE CITY COUNCIL JUSTIFYING WHY THE MAYOR REJECTED THE CANDIDATE.";
