#### INTRODUCTION AND READ FIRST TIME

The President laid before the City Council the following bills and Resolutions of the Mayor and City Council for first reading:

**Bill No. 23-0413** – By City Council President (Administration – Department of Public Works)

A Resolution of the Mayor and City Council repealing the Solid Waste Management Plan for 2013-2023 that was adopted by Resolution 14-019, effective October 30, 2014, as amended by Resolution 15-025, effective December 18, 2015; adopting the Solid Waste Management Plan for 2024-2033; providing for a special effective date; and generally relating to the Solid Waste Management Plan for Baltimore City.

The bill was read the first time and referred to the Economic and Community Development Committee.

**Bill No. 23-0414** – By Councilmember Bullock, President Mosby, Councilmember Ramos, Porter, Cohen, Torrence, Conway, Middleton, Stokes, Costello, and Burnett

A Resolution of the Mayor and City Council forming an inter-departmental work group, including broad representation from stakeholders outside Baltimore City government, to study and make recommendations for reforms to the City's property tax credit system.

The bill was read the first time and referred to the Finance and Performance Committee.

**Bill No. 23-0415** – By Councilmember Porter (Administration – Office of Equity and Civil Rights)

An Ordinance increasing the time within which complaints of unlawful practices must be filed with the Community Relations Commission; making certain related amendments; and providing for a special effective date.

The bill was read the first time and referred to the Education, Workforce, and Youth Committee.

**Bill No. 23-0416** – By Councilmember Torrence, President Mosby, Councilmember Schleifer, Bullock, Burnett, Middleton, Stokes, Ramos, Porter, Glover, Cohen

An Ordinance establishing a Baltimore City Office of Returning Citizens; defining certain terms; providing for the appointment of the Director of the Office; establishing the duties of the Office; providing for the staff and budget of the Office; establishing the Re-Entry Action Council to advise and collaborate with the Office; providing for the appointment, structure, and governance of the Council; requiring the Director, Council members, and staff of the Office to file financial disclosures under the Ethics Code; and requiring that the Office submit an annual report to the Mayor and City Council.

The bill was read the first time and referred to the Public Safety and Government Operations Committee.

### Bill No. 23-0417 – By Councilmember Burnett

An Ordinance purpose of changing the zoning for the properties known as 4911-4917 West Forest Park Avenue and 4919-4925 West Forest Park Avenue, as outlined in red on the accompanying plat, from the R-1 Zoning District to the OS Zoning District.

The bill was read the first time and referred to the Economic and Community Development Committee.

**Bill No. 23-0418** – By Councilmember Burnett, Porter, Dorsey, Middleton, Ramos, Bullock, Cohen, Torrence

An Ordinance prohibiting the use of tobacco products in stadiums; defining certain terms; establishing certain penalties; and providing for a special effective date.

The bill was read the first time and referred to the Health, Environment, and Technology Committee.

### Bill No. 23-0419 – By Councilmember Burnett and President Mosby

An Ordinance requiring that the Department of Public Works submit a report to the Mayor and City Council evaluating the effectiveness of closing the portion of North Franklintown Road extending through Leakin Park to deter illegal dumping; specifying the contents of the report; and providing for a special effective date.

The bill was read the first time and referred to the Public Safety and Government Operations Committee.

### Bill No. 23-0420 – By Councilmember Torrence

An Ordinance establishing a new statutory Residential Permit Parking Area \_\_\_\_ for the Brunt Street Area.

The bill was read the first time and referred to the Economic and Community Development Committee.

**Bill No. 23-0421** – By Councilmember Costello, President Mosby, Councilmember Middleton, Stokes, Torrence, Conway, Ramos, Porter, Glover

An Ordinance requiring certain public service agencies to obtain a certain permit before installing gas metering or regulating equipment on certain real property; specifying documents to be submitted with a permit application; requiring a public service agency to obtain a property owner's consent before a certain permit can be issued; establishing certain exceptions to these requirements; and generally relating to public utilities and permits to install gas metering and regulation equipment.

The bill was read the first time and referred to the Health, Environment, and Technology Committee.

The bill was read the first time and referred to the Public Safety and Government Operations Committee.

### Bill No. 23-0423 – By Councilmember Middleton and President Mosby

An Ordinance changing the name of Cottage Avenue Park, located at North East Side 30 Foot Alley 2nd South West of Cottage Avenue Rear 3700-36 Cottage Avenue (Block 3335, Lot 067), to Candy Stripe Park.

The bill was read the first time and referred to the Economic and Community Development Committee.

### Bill No. 23-0424 – By Councilmember Schleifer

An Ordinance prohibiting unfair, abusive, or deceptive trade practices; establishing certain penalties; authorizing the City Solicitor to take certain action if there is reason to believe a person is engaging in certain practices; defining certain terms; and generally relating to penalties for unfair, abusive, or deceptive trade practices.

# Honoring the Medical Staff of MedStar Harbor Hospital and the R. Adams Cowley Shock Trauma Center

FOR the purpose of formally recognizing the heroic work of the medical staff at MedStar Harbor Hospital and the R. Adams Cowley Shock Trauma Center at the University of Maryland Medical Center in response to the mass shooting at Brooklyn Homes on July 2, 2023.

Now, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That the City Council formally recognizes the heroic work of the medical staff at MedStar Harbor Hospital and the R. Adams Cowley Shock Trauma Center at the University of Maryland Medical Center in response to the mass shooting at Brooklyn Homes on July 2, 2023.

**AND BE IT FURTHER RESOLVED**, That a copy of this Resolution be sent to the President and Chief Executive Officer of MedStar Health, the President and Chief Executive Officer of the University of Maryland Medical Center, and the Mayor's Legislative Liaison to the City Council.

**Bill No. 23-0186R** – By Councilmember McCray, President Mosby, and Councilmember Burnett, Bullock, Conway, Middleton, Schleifer, Stokes, Ramos, Porter, Glover, Cohen, Torrence, Costello

A Resolution inviting the Commissioner of the Department of Housing and Community Development, the Director of the Department of Planning, the Director of the Department of Transportation, the Director of the Department of Public Works, the Director of the Mayor's Office of Children and Family Success, the Executive Director of the Mayor's Office of Neighborhood Safety and Engagement, the City Administrator, and other interested parties to appear before the City Council to discuss: (1) the systemic disinvestment of Baltimore's middle neighborhoods and its connection to the decline in Baltimore's population of working and middle class families; (2) ongoing efforts to revitalize these neighborhoods; (3) future strategies to invest in these neighborhoods; and (4) present challenges to reversing current trends and restoring these once-stable communities.

The bill was read the first time and referred to the Health, Environment, and Technology Committee.

- (3) <u>incorporating climate mitigation and resilience strategies into the implementation</u> of current and future City projects to protect people, property, and communities from the diverse effects of climate change.".

On page 2, in line 17, strike "the design and implementation of" and substitute "designing and implementing".

The amendments were read and adopted.

The bill, as amended, was read the second time and ordered printed for third reading.

On page 7, in line 4, strike "STATUTORY" and substitute "<u>LEGAL</u>"; and, on that same page, in line 5, strike "STATUTE" and substitute "<u>LAW</u>".

### Amendment No. 4
