**INTRODUCTION AND READ FIRST TIME**

The President laid before the City Council the following bills and Resolutions of the Mayor and City Council for first reading:

**Bill No. 21-0023** - By Councilmember Glover:

An Ordinance amending the Urban Renewal Plan for Middle East to modify certain land uses allowed in the Plan, to correct, clarify, and conform certain provisions and references in the Plan to those in the current Baltimore City Zoning Code, to replace Appendix B with new Appendix B, to delete Appendix E in its entirety, to remove certain properties from the lists in Appendices A, C, and D and to remove certain other properties located within the Renewal Area; to replace the exhibits with new exhibits to reflect the changes in the Plan, and to modify the boundaries of the Plan to reflect the removal of certain properties, as shown on the new exhibits; waiving certain content and procedural requirements; making the provisions of this Ordinance severable; providing for the application of this Ordinance in conjunction with certain other ordinances; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Planning Department, Department of Housing and Community Development, Department of Public Works, Commission for Historical and Architectural Preservation, Baltimore Development Corporation, Department of Transportation, Economic and Community Development Committee.

**Bill No. 21-0024** - By Councilmembers Burnett, Cohen, Dorsey, Middleton, Bullock, Torrence:

An Ordinance clarifying the City's minority business and women's business contract utilization requirements for certain emergency procurements; requiring that, after an emergency procurement, the agency submit a report to the Board of Estimates and the Minority and Women's Business Opportunity Office; providing for a special effective date; and generally relating to greater transparency and utilization of minority and women's business in City emergency contracting.

The bill was read the first time and referred to the City Solicitor, Department of Finance, Fire Department, Baltimore Development Corporation, City Administrator, Minority and Women's Business Opportunity Office, Mayor's Office of Minority and Women's Business Development, Office of Emergency Management, Public Safety and Government Operations Committee.

**Bill No. 21-0025** - By Councilmember Cohen (by request):

An Ordinance changing the zoning for the properties known as 2200 (Block 6916, Lot 003), 2220 (Block 6916, Lot 004), 2300 (Block 6916, Lot 005), 2310 (Block 6916, Lot 007), 2330 (Block 6916, Lots 010A and 009), 2400 (Block 6916, Lot 011, and 2500 (Block 6916, Lot 013) Broening Highway and Block 6916, Lot 015, as outlined in red on the accompanying plat, from the OIC Zoning District to the MI Zoning District; and changing the zoning for the properties known as 2205 (Block 6915, Lot 001), 2301 (Block 6915, Lot 006), and 2501 (Block 6915, Lot 009A) Broening Highway, as outlined in blue on the accompanying plat, from the I-2 Zoning District to the MI Zoning District.

The bill was read the first time and referred to the City Solicitor, Board of Municipal and Zoning Appeals, Planning Commission, Department of Housing and Community Development, Baltimore Development Corporation, Department of Transportation, Economic and Community Development Committee.

**Bill No. 21-0026** - By Councilmember Porter (by request):

An Ordinance changing the zoning for the property known as 1201 South Caton Avenue (Block 2108C, Lot 002), as outlined in red on the accompanying plat, from the EC-1 Zoning District to the I-1 Zoning District; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Board of Municipal and Zoning Appeals, Planning Commission, Department of Housing and Community Development, Baltimore Development Corporation, Department of Transportation, Economic and Community Development Committee.

**Bill No. 21-0027** - By Councilmember Costello:

An Ordinance amending the Parking Management Plan for RPP Area 9 to add an exception to the Plan's general permit allotments for dwelling units.

The bill was read the first time and referred to the City Solicitor, Department of Planning, Department of Housing and Community Development, Police Department, Department of Transportation, Baltimore City Parking Authority Board, Economic and Community Development Committee.

**Bill No. 21-0028** - By Councilmember Ramos:

An Ordinance designating the Clifton School, 2670 Kennedy Avenue, as an historical landmark: exterior.

The bill was read the first time and referred to the City Solicitor, Board of Municipal and Zoning Appeals, Planning Commission, Department of Housing and Community Development, Commission for Historical and Architectural Preservation, Baltimore Development Corporation, Education, Workforce, and Youth Committee.

**Bill No. 21-0029** - By Councilmembers Dorsey, Burnett, Cohen, Bullock:

An Ordinance modifying the annual licensing fee for commercial parking facilities within the City of Baltimore and how the fee is calculated; beginning on a certain date, providing for the annual adjustment of the licensing fee for inflation as measured by the Consumer Price Index; and conforming related provisions.

The bill was read the first time and referred to the City Solicitor, Department of Transportation, Baltimore City Parking Authority Board, Department of Finance, Ways and Means Committee.

**Bill No. 21-0030** - By Councilmembers Burnett, Cohen, Dorsey, Porter, Middleton, Bullock, Ramos, Torrence, Schleifer:

An Ordinance requiring that the City Administrator coordinate a multi-agency code inspection after a commercial property has been issued certain environmental citations; requiring that the City Administrator and the Department of Housing and Community Development receive a copy of all environmental citations issued; specifying which agencies must be included in the multi-agency inspection team; requiring that the City Administrator provide certain information to councilmembers; requiring that the City Administrator submit an annual report detailing the work of the multi-agency inspection team; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Department of Public Works, Department of Housing and Community Development, Department of Finance, City Administrator, Environmental Control Board, Fire Department, Health Department, Mayor's Office of Performance and Innovation, Public Safety and Government Operations Committee.

**Bill No. 21-0031** - By Councilmember Glover, President Mosby, Councilmembers Middleton, Ramos, Stokes, Bullock:

An Ordinance requiring, absent certain good cause circumstances, landlords to offer tenants a reasonable opportunity renew leases; providing for the manner of notice for which a landlord must send renewal notices or decline-to-renew notices; establishing a presumption of offer and acceptance, absent certain circumstances; providing for the effect of the subtitle; providing for certain administrative and criminal penalties; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Department of Housing and Community Development, Housing Authority of Baltimore City, Sheriff's Office, Department of Finance, Economic and Community Development Committee.

The President laid before the City Council the following Council Resolutions for first reading:

The bill was read the first time and referred to the City Solicitor, 311, Department of Public Works, Health Department, Department of Transportation, Department of Housing and Community Development, Department of Recreation and Parks, City Administrator, Baltimore Development Corporation, Mayor's Office of Performance and Innovation, Environmental Control Board, Baltimore City Information Technology, Health, Environment, and Technology Committee.

**Bill No. 21-0011R** - By Councilmembers Middleton, McCray, Burnett, Bullock:

A Resolution inviting the Chief Executive Officer of the Baltimore City Public School System, the Commissioners from the Board of School Commissioners for the Baltimore City Public School System, the Director of the Mayor's Office of Employment Development, and the



Executive Director of the Mayor's Office of Children and Family Success to appear before the City Council to discuss how we can: develop curriculum content for a course in financial literacy; require that the curriculum content include instruction in choosing a career, earning an income, saving and investing money, credit, and budgeting; and require students to complete a course in financial literacy in order to graduate from high school in Baltimore City Public Schools.

The bill was read the first time and referred to the City Solicitor, Baltimore City Public School System, Mayor's Office of Employment Development, Mayor's Office of Children and Family Success, Department of Finance, Education, Workforce, and Youth Committee.

**Bill No. 21-0012R** - By Councilmembers Stokes, McCray, Middleton, Burnett, Bullock, Ramos, Torrence, Conway, Glover, Cohen:

A Resolution inviting the CEO of the Baltimore City Public School System to provide the City Council with an update regarding safety precautions the School System is taking for the return of students to in-person schooling and inviting representatives from the Baltimore City Fire Department, Health Department, and Department of Housing and Community Development to comment on the adequacy of those safety precautions.

The bill was read the first time and referred to the City Solicitor, Baltimore City Public School System, Fire Department, Health Department, Department of Housing and Community Development, Mayor's Office of Children and Family Success, Education, Workforce, and Youth Committee.
