I am pleased to inform your Honorable Body that I have signed into law this day these bills which are routine and require no special treatment:

**Bill 21-0007** - An Ordinance concerning - COVID-19 Restaurant, Consumer, and Gig Worker Relief Act (Temporary Limit on Third-Party Delivery Service Fees) - For the purpose of establishing certain temporary regulations on third-party food delivery platforms; defining certain terms; authorizing the Director of Finance to adopt rules and regulations to implement and enforce this subtitle; setting forth certain prohibited conduct for third-party food delivery platforms; providing for enforcement by citation; providing for certain criminal and administrative penalties; providing for this Ordinance's severability; setting forth a certain termination date; providing for a special effective date; and generally relating to the regulation of third-party food delivery platforms and the economic well-being of Baltimore restaurants, consumers, and gig workers during the COVID-19 pandemic.

#### INTRODUCTION AND READ FIRST TIME

The President laid before the City Council the following bills and Resolutions of the Mayor and City Council for first reading:

**Bill No. 21-0032** - By the Council President and Councilmember Middleton (The Administration)

An Ordinance establishing the salary of the Director of Public Works; and providing for a special effective date.

The bill was read the first time and referred to the Ways and Means Committee.

**Bill No. 21-0033** - By Councilmembers Ramos, Burnett, Middleton, Dorsey, Cohen, Stokes, Glover

An Ordinance creating a LGBTQ Business Enterprise (“LGBTQBE”) Program, to be administered by the Minority and Women’s Business Opportunity Office; defining certain terms; establishing the eligibility requirements for firms seeking to participate in the LGBTQBE Program; establishing revocation criteria for firms in the LGBTQBE Program; authorizing the City to employ various affirmative procurement initiatives to promote the award of City contracts to LGBTQBEs; requiring annual reports on the LGBTQBE Program; requiring periodic hearings on and review of the LGBTQBE Program; providing for the appeal of certain adverse determinations by the Minority and Women’s Business Opportunity Office; setting certain penalties; correcting, conforming, and clarifying related provisions; renumbering certain sections; and generally relating to City procurement requirements.

The bill was read the first time and referred to the City Solicitor, Minority and Women’s Opportunity Office, Mayor’s Office of Minority and Women’s Business Development, Executive Office of the Mayor, Baltimore City Information and Technology, Mayor’s Office of Equity and Civil Rights, Comptroller, Department of Finance, and the Public Safety and Government Operations Committee.

**Bill No. 21-0034** - Councilmember Ramos

An Ordinance prohibiting the Mayor and City Council from conducting or otherwise scheduling a tax sale pursuant to Title 14, Subtitle 8, Part III {“Tax Sales”} of the State Tax-Property Article during the 2021 calendar year; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Department of Housing and Community Development, Department of Finance, Mayor’s Office, and the Ways and Means Committee.

**Bill No. 21-0035** - Councilmember Torrence

An Ordinance designating the Reed Calloway House, 1316 North Carey Street, as an historical landmark: exterior.

The bill was read the first time and referred to the City Solicitor, Board of Municipal and Zoning Appeals, Planning Commission, Department of Housing and Community Development, Commission for Historical and Architectural Preservation, Baltimore Development Corporation, and the Education, Workforce, and Youth Committee.

**Bill No. 21-0036** - Councilmembers Dorsey, Burnett, Cohen, Porter, Torrence, Schleifer, Ramos

An Ordinance establishing a common set of definitions, rules of interpretation, and methods for time computation for the Baltimore City Code.

The bill was read the first time and referred to the City Solicitor, Department of Finance, Department of Legislative Reference, and the Rules and Legislative Oversight Committee.

**Bill No. 21-0037** - Councilmember Dorsey, Burnett, Cohen, Conway, Bullock

An Ordinance requiring certain businesses to provide premium pay to gig workers; prohibiting certain businesses from taking certain adverse actions against gig workers; requiring certain businesses to keep certain records of their compliance with the premium pay requirements; requiring certain notices to be provided to gig workers; including the premium pay provisions within the Baltimore City Wage Commission's scope of enforcement; applying certain fines and penalties for violations of premium pay provisions; defining certain terms; and generally relating to guaranteeing a fair wage to gig workers in Baltimore City.

The bill was read the first time and referred to the City Solicitor, Labor Commissioner, Department of Human Resources, Wage Commission, Department of Finance, Baltimore Development Corporation, Downtown Partnership, and the Education, Workforce, and Youth Committee.

**Bill No. 21-0038** - Councilmembers Burnett, Cohen, Dorsey, Porter, Middleton, Bullock

An Ordinance requiring city-owned or -occupied buildings to place a notice regarding the human-trafficking prevention hotline in certain locations; deleting an obsolete reference to the "Maryland Department of Labor, Licensing, and Regulation"; providing that certain businesses may obtain the required human-trafficking notices from the United States Department of Homeland Security's Blue Campaign website; and conforming and clarifying related provisions.

The bill was read the first time and referred to the City Solicitor, Baltimore Development Corporation, Health Department, Police Department, Department of Housing and Community Development, Mayor's Office of Homeless Services, Mayor's Office of Criminal Justice, Department of General Services, Department of Social Services, Finance Department, Mayor's Office of Neighborhood Safety and Engagement, and the Public Safety and Government Operations Committee.

**Bill No. 21-0039** - Councilmember Stokes, Council President Mosby, Councilmembers Schleifer, Conway, Costello, Glover, Middleton, Porter, Torrence, Ramos, Cohen, Bullock

An Ordinance requiring certain contractors to create and submit to the Director of the Department of Finance initial employment plans to bid on government-assisted construction projects or contracts that receive government assistance totaling \$5 million or more; requiring the Director of the Department of Finance to score the bids using the Director's evaluation of the

employment plan as 10% of a bidder's score; requiring the winning bidder to submit a revised employment plan to the Director of the Department of Finance with certain criteria; and conforming related provisions.

The bill was read the first time and referred to the City Solicitor, Mayor's Office of Employment Development, Department of Finance, and the Education, Workforce, and Youth Committee.

The President laid before the City Council the following Council Resolutions for first reading:

**Bill No. 21-0016R** - By Councilmembers Burnett, Cohen, Dorsey, Porter, Middleton, Ramos, Bullock

A Resolution inviting representatives from the Department of Public Works, the Law Department, the Health Department, and the Mayor's Office of Emergency Management to appear before the City Council to discuss the effectiveness and sufficiency of measures being taken to address basement backups of raw sewage in the City.

The bill was read the first time and referred to the City Solicitor, Department of Public Works, Department of Health, Mayor's Office of Emergency Management, 311 Services, Finance Department, Department of Housing and Community Development, Mayor's Office of Performance and Initiative, and the Health, Environment, and Technology Committee.

**Bill No. 21-0017R** - By Councilmembers Burnett, Porter, Middleton, Bullock, Cohen, Stokes

A Resolution inviting representatives from the Baltimore City Fire Department, the Baltimore Police Department, the Office of the State's Attorney for Baltimore City, the Baltimore City Health Department, the Baltimore City Department of Housing and Community Development, the Mayor's Office of Criminal Justice, the Baltimore City Public School System, and the Mayor's Office of Homeless Services to appear before the City Council to discuss arsons, fire fatalities and injuries, and school fires; how we can work to re-institute the Joint Agency Arson Task Force; and discuss other tools that would assist in the prevention or prosecution of arson.

The bill was read the first time and referred to the Fire Department, Police Department, State's Attorney, Department of Health, Mayor's Office of Criminal Justice, Baltimore City Public School System, Mayor's Office of Homeless Services, City Solicitor, Department of Housing and Community Development, Department of Finance, Mayor's Office of Neighborhood Safety and Engagement, and the Public Safety and Government Operations Committee.

**Bill No. 21-0018R** - By Councilmembers McCray, Porter, Ramos, Middleton, Stokes, Torrence, Bullock, Cohen

A Resolution inviting the Director of the Department of Human Resources, the Director of the Department of Finance, the Director of the Baltimore City Office of Information & Technology, and other interested parties to appear before the Baltimore City Council to discuss: the development and implementation process of the Workday Enterprise System; what focus groups or other workgroups were created to identify potential problems during the development process; what offline performance tests were conducted to identify potential gaps in service delivery capabilities; and what corrective processes have been put in place to remedy the countless problems that the city has faced during this implementation process.

The bill was read the first time and referred to the City Solicitor, Department of Human Resources, Baltimore City Information and Technology, Department of Finance, City Administrator, and the Public Safety and Government Operations Committee.

**A COUNCIL RESOLUTION CONCERNING**

**Investigative Hearing – Safe Return to In-Person Schooling**

FOR the purpose of inviting the CEO of the Baltimore City Public School System to provide the City Council with an update regarding safety precautions the School System is taking for the return of students to in-person schooling and inviting representatives from the Baltimore City Fire Department, Health Department, and Department of Housing and Community Development to comment on the adequacy of those safety precautions.

**Recitals**

**WHEREAS**, Due to the pandemic, the majority of Baltimore City schoolchildren have been participating in virtual schooling since last spring;

**WHEREAS**, The Baltimore City Public School System (“BCPSS”) will gradually introduce more students back to traditional in-person classes beginning with the start of the second semester, specifically students in kindergarten through 5<sup>th</sup> grade as well as 9<sup>th</sup> and 12<sup>th</sup> grade students, although families will have the option to remain in virtual learning; and

**WHEREAS**, The City Council and the public need to know what safety precautions BCPSS is taking in reopening schools to some students, such as whether all teachers will be vaccinated before students are allowed back, how classrooms will be organized for social distancing, information regarding ventilation systems in the schools, and whether the systems can adequately protect building visitors, etc.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE**, That the City Council invites the CEO of the Baltimore City Public School System is taking for the return of students to in-person schooling and inviting representatives from the Baltimore City Fire Department, Health Department, and Department of Housing and Community Development to comment on the adequacy of those safety precautions.

**AND BE IT FURTHER RESOLVED**, That a copy of this Resolution be sent to the Mayor, the CEO of the Baltimore City Public School System, the Health Commissioner, the Fire Chief, the Acting Commissioner of the Department of Housing and Community Development, and the Mayor's Legislative Liaison to the City Council.
