**INTRODUCTION AND READ FIRST TIME**

The President laid before the City Council the following bills and Resolutions of the Mayor and City Council for first reading:

**Bill No. 21-0071** - By The Council President (on behalf of the Administration [Department of Transportation])

An Ordinance permitting, subject to certain conditions, the construction and maintenance of a portion of a building projecting into the public right-of-way on the south side of Eastern Avenue, on the property known as 1707 Eastern Avenue.

The bill was read the first time and referred to the City Solicitor, Board of Municipal and Zoning Appeals, Department of Planning, Department of Housing and Community Development,

Department of Transportation, Fire Department, Parking Authority, and the Economic and Community Development Committee.

**Bill No. 21-0072** - The Council President (on behalf of the Administration [Department of Finance])

An Ordinance revising the local 911 telephone fee; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Fire Department, Department of Finance, Police Department, Information and Technology, and the Ways and Means Committee.

**Bill No. 21-0073** - Councilmember Conway

An Ordinance permitting, subject to certain conditions, the establishment, maintenance, and operation of a banquet hall on both floors of the property known as 5600 York Road (also known as 5602A York Road) (Block 5014C, Lot 001), as outlined in red on the accompanying plat.

The bill was read the first time and referred to the City Solicitor, Board of Municipal and Zoning Appeals, Department of Housing and Community Development, Department of Transportation, Fire Department, Parking Authority, Planning Commission, Baltimore Development Corporation, and the Economic and Community Development Committee.

**Bill No. 21-0074** - Councilmember Conway, Torrence, Porter

An Ordinance repealing Article 1, Subtitle 18 {"Disaster Control and Civil Defense"} as obsolete; establishing an Office of Emergency Management as an independent agency; defining certain terms; providing for the appointment of an Executive Director of the Office; setting forth certain duties of the Executive Director; providing for a staff and budget for the Office; requiring the Office to include specific Emergency Support Functions in the Emergency Operations Plan; requiring the Office to coordinate with certain City agencies in writing the Emergency Operations Plan; requiring the Office to update the City Emergency Operations Plan quadrennially and submit the updated Plan and a memorandum regarding changes made to the Plan to the Mayor and the City Council; requiring the Office to report annually to the Mayor and the City Council on certain activities and metrics; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Fire Department, Department of Finance, Mayor's Office of Emergency Management, City Administrator, and the Public Safety and Government Operations Committee.

**Bill No. 21-0075** - Councilmember Burnett, Cohen, Dorsey, Ramos, Bullock

An Ordinance requiring that the Baltimore City Department of Public Works submit a report to the Mayor and City Council studying the feasibility of implementing an expedited reimbursement and direct assistance program for any sewage backup, not limited to wet-weather, capacity-related causes; requiring certain agency assistance; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Department of Housing and Community Development, Department of Finance, Information and Technology, Department of Public Works, Health Department, and the Health, Environment, and Technology Committee.

**Bill No. 21-0076** - President Bullock

An Ordinance permitting, subject to certain conditions, the conversion of a single-family dwelling unit to 2 dwelling units in the R-8 Zoning District on the property known as 1049 Brantley Avenue (Block 0115, Lot 069), as outlined in red on the accompanying plat; and granting a variance from certain bulk regulations (lot area size).

The bill was read the first time and referred to the City Solicitor, City Solicitor, Board of Municipal and Zoning Appeals, Department of Housing and Community Development, Department of Transportation, Fire Department, Parking Authority, Planning Commission, Baltimore Development Corporation, and the Economic and Community Development Committee.

**Bill No. 21-0077** - Councilmember Bullock

An Ordinance permitting, subject to certain conditions, the conversion of a single-family dwelling unit to 5 dwelling units in the R-8 Zoning District on the property known as 1110 W. Lafayette Avenue (Block 0079, Lot 004A), as shown on the accompanying plat with the lot number circled.

The bill was read the first time and referred to the City Solicitor, Board of Municipal and Zoning Appeals, Department of Housing and Community Development, Department of Transportation, Fire Department, Parking Authority, Planning Commission, Baltimore Development Corporation, and the Economic and Community Development Committee.

**Bill No. 21-0078** - Councilmember Ramos, Conway, Cohen, Middleton, Torrence

An Ordinance requiring certain disclosures in order to sell a property that was formerly issued a vacant building notice; and providing for certain penalties.

The bill was read the first time and referred to the City Solicitor, Department of Planning, Department of Housing and Community Development, Baltimore Development Corporation, Department of Real Estate, and the Economic and Community Development Committee.

**Bill No. 21-0079** - Councilmember Costello

An Ordinance repealing Ordinance 90-425, as amended by Ordinance 00-57, Ordinance 02-431, Ordinance 04-884, and Ordinance 16-572, which designated certain properties as an Industrial Planned Unit Development known as Port Covington; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Board of Municipal and Zoning Appeals, Department of Housing and Community Development, Department of Transportation, Fire Department, Parking Authority, Planning Commission, Baltimore Development Corporation, Department of Public Works, and the Economic and Community Development Committee.

Biden and the United States Congress to enact legislation to provide a pathway to citizenship for immigrant essential workers, children who qualified for the Deferred Action for Childhood Arrivals (DACA) and residents who are under the Temporary Protective Status (TPS) program and their spouses and children, as part of the federal economic recovery program.

**A COUNCIL RESOLUTION CONCERNING**

**Keeping the Promise – Urging President Biden to  
Provide a Pathway to Citizenship for Immigrant Essential Workers**

FOR the purpose of urging President Joseph R. Biden and the United States Congress to enact legislation to provide a pathway to citizenship for immigrant essential workers, children who qualified for the Deferred Action for Childhood Arrivals (DACA) and residents who are under the Temporary Protective Status (TPS) program and their spouses and children, as part of the federal economic recovery program.

**Recitals**

**WHEREAS**, Baltimore is a Welcoming City where immigrants of diverse racial, ethnic, and religious backgrounds are welcome to live, work, learn, play, and thrive;

**WHEREAS**, Baltimore’s immigrant community members are essential workers, taxpayers, and contributors to our neighborhoods;

**WHEREAS**, Baltimore is home to 11,000 immigrants, who live across our City and contribute to our local economy and community;

**WHEREAS**, immigrant communities in Baltimore and across the country suffered greatly from COVID-19 and yet were ineligible for several aid programs and insurance, even though they are tax-paying residents;

**WHEREAS**, immigrant essential workers in our City have been critical to our City during the COVID-19 pandemic, filling critical roles in our health care and education sectors and serving as “frontline” workers in our food security, public safety, transportation, and critical infrastructure systems to continue to serve all of our residents and providing critical services and care during the COVID-19 pandemic;

**WHEREAS**, granting a pathway to citizenship for these valuable contributors to our community and economy would result in increased economic output, average wages, and increased productivity; and

**WHEREAS**, the City of Baltimore advocates for comprehensive immigration reform through its federal legislative agenda, which urges the United States Congress to enact legislation to provide a realistic pathway to citizenship; works to keep families intact; promotes public safety, national security, and economic prosperity; and respects human rights and liberties, as noted in Council Bills 06-017R and 18-0093R.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE**, That the Council urges President Joseph R. Biden and the United States Congress to enact legislation to provide a pathway to citizenship for immigrant essential workers, children who qualified for the Deferred Action for Childhood Arrivals (DACA) and residents who are under the Temporary Protective Status (TPS) program and their spouses and children, as part of the federal economic recovery program.

**AND BE IT FURTHER RESOLVED**, That a copy of this Resolution be sent to the President of the United States, the Vice President of the United States, the Secretary of the Department of Homeland Security, the Director of the Domestic Policy Council, the Honorable members of the Maryland delegations to the United States Senate and the United States House of Representatives, the Mayor, and the Mayor's Legislative Liaison to the City Council.

An Ordinance modifying the applicable environmental control citation and civil citation fines for violating Title 7, Subtitle 6 of the Baltimore City Health Code; and requiring that the Health Commissioner submit an annual report detailing certain information regarding the City's prohibited disposal laws.

**A COUNCIL RESOLUTION CONCERNING**

**Informational Hearing - Studying the Feasibility of a Small Hauler Incentive Program**

FOR the purpose of inviting representatives from the Department of Finance, Department of Public Works, and the Department of Health to discuss the feasibility of enacting a small hauler incentive program to better offset illegal dumping and litter in our communities.

**Recitals**

It is no secret that Baltimore has an illegal dumping and litter problem. Due to the transient nature of the issue, enforcement can be incredibly tricky. Thus, we as a City government must begin to think outside of the box on solutions, in addition to mere enforcement.

In the vein of previous enactments such as the Private Security Camera Rebate Program, one such solution could be the enactment of a small hauler incentive program that would incentivize small haulers to join in the effort to rid our communities of unsightly and unhealthy trash.

The broad contours of the program would be simple. If you are licensed as a small hauler and you live or your business is located within the City, you would be eligible for a payment of \$75 per ton of waste that you dispose of at the City's Quarantine Road facility. The hauler would be responsible for maintaining the proper documentation indicating the dates and tonnage of waste disposed at Quarantine Road facility.

Obviously, in order for a proposal such as this to be effective, there are details that need to be discussed, such as whether the City could afford this program and, if not, are there alternative funding streams that could be made available, such as grants; and whether the relevant agencies could implement this program without additional staffing or administrative resources.

Thus, this hearing would serve as a beginning point in a discussion that may ultimately produce effective legislation resulting in tangible benefits to the people and communities of Baltimore.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE,** That the Council invites representatives from the Department of Finance, Department of Public Works,



and the Department of Health to discuss the feasibility of enacting a small hauler incentive program to better offset illegal dumping and litter in our communities.

**AND BE IT FURTHER RESOLVED**, That a copy of this Resolution be sent to the Mayor, the Director of Finance, the Acting Director of the Department of Public Works, the Commissioner of Health, and the Mayor's Legislative Liaison to the City Council.

**A COUNCIL RESOLUTION CONCERNING**

**Investigative Hearing – Women in Public Safety:  
Leveling the Playing Field**

FOR the purpose of requesting that the Chief of the Baltimore City Fire Department, the Commissioner of the Baltimore Police Department, and the Director of the Department of Human Resources come before the Baltimore City Council to provide information about their agencies' strategy to recruit, retain, mentor, and promote more women.

**Recitals**

Female representation in the nation's approximately 18,000 law enforcement agencies has remained stagnant around 12% for more than 25 years. That number gets smaller when evaluated in the promotional process, as women make up just 3% of police executive leadership positions. Statistics from the organization Women in Fire show that females in fire and emergency medical service organizations face the same plight, as they make up just 3.7% of their industries

workforce in the United States, with women of color accounting for 1 in 5 females in the profession.

When it comes to the Baltimore Police Department and the Baltimore City Fire Department their statistics are on par with national averages. It has been reported that of the Police Department's nearly 2,500 sworn officers, less than 400, or 16%, are women. Similarly, the Fire Department has approximately 1,700 uniformed personnel, but fewer than 250, or 14%, are women.

The low numbers faced by women in these professions are a problem that stems from disproportionate barriers in recruitment, retention, mentorship, and the promotion of experienced women. Historically, both our local agencies have dealt with issues of equity in their promotional practices, more specifically as it relates to women. In the Baltimore Police Department, it was not until 1978 when the first woman was promoted through the ranks and held the command-level position of Major. More recently, in 2020, the Baltimore City Fire Department promoted the first woman to rise through the ranks to the command-level position of Deputy Chief.

Baltimore City has never had a woman lead our Fire or Police Departments. Yet, at this very moment in time, the City lags behind its neighbors in Anne Arundel County, Baltimore County, Howard County and Prince George's County, all of whom have or have had a woman serve as their jurisdictions Fire Chief or Police Chief. Public-safety professionals serving in the community are often times the most visible manifestation of government to the public. Because of this, it is critical that the selection process that we use to recruit, hire and promote employees in public safety agencies represents the diversity of our communities.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE,** That the Council requests that the Chief of the Baltimore City Fire Department, the Commissioner of the Baltimore Police Department, and the Director of the Department of Human Resources come before the Baltimore City Council to provide information about their agencies' strategy to recruit, retain, mentor, and promote more women.

**AND BE IT FURTHER RESOLVED,** That a copy of this Resolution be sent to the Mayor, the Chief of the Baltimore City Fire Department, the Commissioner of the Baltimore Police Department, the Director of the Department of Human Resources, and the Mayor's Legislative Liaison to the City Council.

**A COUNCIL RESOLUTION CONCERNING**

**Investigative Hearing – COVID-19 and Small Business Re-Openings**

FOR the purpose of inviting representatives from the Baltimore Development Corporation to brief the City Council on their efforts to support small businesses and economic development in light of the COVID-19 pandemic.

**Recitals**

COVID-19 has had a significant impact on Baltimore’s economy, especially the small business community. The Baltimore Development Corporation (“BDC”) is the City’s economic development agency. BDC has led the City’s response and recovery effort with respect to the economic crisis brought on by the COVID-19 pandemic.

BDC has strived to deliver an innovative and equitable response to help local business through the pandemic and has emphasized supporting resident-, women- and Black, Indigenous and People of Color (BIPOC)-owned businesses. BDC’s efforts have been recognized both locally and nationally.

To date, BDC has awarded over 1,000 small business assistance grants totaling approximately \$13 million. Sixty-three percent of all small business assistance grants were awarded to BIPOC-owned businesses; 57% of all small business assistance grants were awarded

to women-owned businesses; and 66% of all small business assistance grants were award to Baltimore City resident-owned businesses.

With the onset of the COVID-19 pandemic, BDC and the Baltimore Small Business Support Fund (“BSBSF”) partnered to ensure relief resources reached as many businesses as possible and especially BIPOC-owned businesses in disinvested neighborhoods. This partnership formed the Baltimore Small Business Technical Assistance Network (“TA Network”), a partnership of 19 organizations coordinated by BDC and funded by the BSBSF coalition of foundations. To date, the TA Network has more than 1,400 business tracked in its shared database. Sixty percent of the businesses are BIPOC-owned and 80% of the businesses are sole proprietors or have five or fewer employees.

As BDC addresses the current economic crisis, the agency is also undertaking a robust economic strategic planning effort. BDC recently released an interim report on its Comprehensive Economic Development Strategy named “Baltimore Together – A Platform for Inclusive Prosperity”. This effort describes the BDC will take to promote inclusive economic recovery and growth in the City over the next 5 years.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE,** That the City Council invites representatives from the Baltimore Development Corporation to brief the City Council on their efforts to support small businesses and economic development in light of the COVID-19 pandemic.

**AND BE IT FURTHER RESOLVED,** That a copy of this Resolution be sent to the Mayor, the President and CEO of the Baltimore Development Corporation, and the Mayor’s Legislative Liaison to the City Council.

### **A COUNCIL RESOLUTION CONCERNING**

#### **Informational Hearing – Building a Homegrown Public Safety Cadet Program**

FOR the purpose of inviting the Police Commissioner of the Baltimore Police Department, the Fire Chief of the Baltimore City Fire Department, the Director of the Office of Emergency Management, the Sheriff of the Baltimore City Sheriff's Office, the Police Chief of the Baltimore City School Police, the Director of the Mayor's Office of Employment Development, the Director of the Department of Human Resources, and the head of the Baltimore City Public School System's Career and Technology Education program to appear before the Baltimore City Council to discuss: the Baltimore City Fire and Police Department's explorer programs; youth works programs; cadet programs; college internship programs; the successes and opportunities with local recruiting and hiring initiatives; and establishing the best method to create a pipeline of homegrown talent into Baltimore City public safety agencies.

#### **Recitals**

**WHEREAS**, public safety in the City of Baltimore is consistently the number one issue every year.

**WHEREAS**, crime and poverty both have a direct link to a lack of exposure, resources and opportunities within any community.

**WHEREAS**, the Baltimore Police Department employs approximately 2,500 people, yet less than 500 of those employees live in Baltimore City.

**WHEREAS**, the Baltimore City Fire Department employs approximately 1,700 people, yet less than 400 of those employees live in Baltimore City.

**WHEREAS**, police officers, firefighters, paramedics, emergency medical technicians and other fire and police department personnel are consistently the top wage earners in City government.

**WHEREAS**, a recent audit conducted by the Education Strategy Group of the Baltimore City Public School System's Career and Technology Education program found that students who went through the city's vocational training programs earned an annual median income of less than \$13,000 per year.

**WHEREAS**, hundreds of Baltimore City high school students graduate each year without leads on employment opportunities, and our public safety agencies combined have hundreds of vacancies to fill.

**WHEREAS**, we need to make the financial investment to allocate funding for 100 public safety cadet positions to employ local youth upon graduation.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE**, that the Council invites the Police Commissioner of the Baltimore Police Department, the Fire Chief of the Baltimore City Fire Department, the Director of the Office of Emergency Management, the Sheriff of the Baltimore City Sheriff's Office, the Police Chief of the Baltimore City School Police, the Director of the Mayor's Office of Employment Development, the Director of the Department of Human Resources, and the head of the Baltimore City Public School System's Career and Technology Education program to appear before the Baltimore City Council to discuss: the Baltimore City Fire and Police Department's explorer programs; youth works programs; cadet programs; college internship programs; the successes and opportunities with local recruiting and hiring initiatives; and establishing the best method to create a pipeline of homegrown talent into Baltimore City public safety agencies.

**AND BE IT FURTHER RESOLVED**, That a copy of this Resolution be sent to the Mayor, the Police Commissioner of the Baltimore Police Department, the Fire Chief of the Baltimore City Fire Department, the Director of the Office of Emergency Management, the Sheriff of the Baltimore City Sheriff's Office, the Police Chief of the Baltimore City School Police, the Director of the Office of Employment Development, the Director of the Department of Human Resources, and the head of the Career and Technology Education program from the Baltimore City Public School System, and the Mayor's Legislative Liaison to the Baltimore City Council.
