Re: Riverside Residential Permit Parking

Dear President Mosby:

This letter serves as notice of the Parking Authority of Baltimore City's intent to renew the administrative regulation for the Residential Permit Parking (RPP) area known as RPP Area 48, Riverside, indefinitely. RPP Area 48 was created by a 6-month administrative regulation that became effective on February 1, 2021. Pursuant toArticle31,10-18(b)(1), the Parking Authority of Baltimore City is required to notify the President of the City Council of its intent to renew an administrative regulation creating an RPP area, not less than 30 days before the expiration of the 6-month administrative regulation creating an RPP. The 6-month administrative regulation for RPP Area 46 will expire on July31, 2021. Please accept this letter as the required notice of the intent to renew the administrative regulation for RPP Area 48 indefinitely. Pursuant to Article 31, 10-18 (b)(2), if no written objection to the extension is made by any member of the City Council representing all or part of the affected area and forwarded to the Executive Director within thirty (30) days of the notice to extend, the administrative regulation will be extended at the end of the 6-month period.

THIRD READING TODAY

The President laid before the City Council:

BILL No. 21-0001 - An Ordinance prohibiting Baltimore City government from purchasing or obtaining certain face surveillance technology; prohibiting Baltimore City government from contracting or subcontracting with another for the purpose of face surveillance technology; prohibiting any person in Baltimore City from obtaining, retaining, accessing, or using certain face surveillance technology;

requiring the Director of Baltimore City Information and Technology to submit an annual report to the Mayor and City Council regarding the use of surveillance by the Mayor and City Council; providing for certain termination dates; providing for certain penalties; and defining certain terms.

It was read the third time.

The bill being on its final passage, the year and nays were called, resulting as follows:

Yeas - President and Councilmembers Cohen, McCray, Dorsey, Conway, Middleton, Torrence, Burnett, Bullock, Porter, Stokes, Glover, Ramos - Total 12.

Nays - Councilmember Schleifer, Costello - Total 2.

The bill was read and approved, and the bill was declared "Passed".

BILL No. 21-0019 - An Ordinance establishing a Baltimore City Office of LGBTQ Affairs; defining certain terms; providing for the appointment of the Director of the Office; establishing the duties of the Office; providing for the staff and budget of the Office; establishing a LGBTQ Commission to advise and collaborate with the Office; proving providing for the appointment, structure, and governance of the Commission; requiring the Director, Commission members, and staff of the Office to file financial disclosures under the Ethics Code; and requiring that the Office submit an annual report to the Mayor and City Council.

It was read the third time.

The bill being on its final passage, the year and nays were called, resulting as follows:

Yeas - President and Councilmembers Cohen, McCray, Conway, Schleifer, Middleton, Torrence, Burnett, Bullock, Porter, Costello, Stokes, Glover, Ramos - Total 14.
