Councilmember Middleton, for the Economic and Community Development Committee, reported Bill No. 21-0071 favorably.

An Ordinance permitting, subject to certain conditions, the construction and maintenance of a portion of a building projecting into the public right-of-way on the south side of Eastern Avenue, on the property known as 1707 Eastern Avenue.

# BILL NO. 21-0090 REPORTED FAVORABLY, WITH AMENDMENTS, AND ORDERED PRINTED FOR THIRD READING

# BILL NO. 21-0063R REPORTED FAVORABLY AND ORDERED PRINTED FOR THIRD READING

Councilmember Conway, for the Public Safety and Government Operations Committee, reported Bill No. 21-0063R favorably.

A resolution requesting the Executive Director of the Baltimore City Fire and Police Employees' Retirement System, the Board of Trustees for the Baltimore City Fire and Police Employees' Retirement System, the Director of the Department of Finance, representatives from the Baltimore Police Department, and representatives from the Baltimore City Fire Department come before the City Council to discuss the Deferred Retirement Option Plan ("DROP"), analyze current and former participation in the program, brief the Council on policy differences between the original DROP program and DROP 2, and share what modifications the City can make to the policy that would allow us to use it as an incentive to retain veteran fire and police personnel.

# BILL NO. 21-0118 REPORTED FAVORABLY, WITH AMENDMENTS, AND ORDERED PRINTED FOR THIRD READING

Councilmember Costello, for the Ways and Means Committee, reported Bill No. 21-0118 favorably, with amendments.

An Ordinance approving the application of Downtown Partnership of Baltimore to designate an Area of Special Sign Control known as the North Harbor District; and providing for a special effective date.

### FINDINGS OF FACT

City Council Bill No: 21-0118

Upon finding with regard to:

- (1) The designation will not increase the likelihood of traffic congestion or distraction: Downtown Baltimore has a lot of existing traffic and the presence of large billboards will not increase the amount of traffic congestion.
- (2) The designation will not add to the visual clutter in the area: Though there is some concern regarding architectural issues, those can be addressed through the architectural standards for the billboards coming. Because of the dense nature of the zone, those issues do not present a reason to not allow the Area of Special Sign Control; but could look at it again later with the specific plans in mind to address any future visual clutter concerns.
- (3) The designation will not be incongruous with the existing or contemplated design of downtown area: In the case of the downtown district, having digital billboards and special signing, is quite congruous with the neighborhood and with a downtown business district that

Baltimore wants to have. In addition, there is some level of cost benefit analysis and that there's a significant need for downtown to grow and to be strategic about trying to build businesses.

and, on page 2, strike lines 1 through 4 in their entireties.
